Jail Bond Term: County Administrator Debra Shackett reviewed the comparison spreadsheet and recommended scenario #2. Commissioner DeVoy stated he liked scenario #4. Commissioner Waring stated he liked scenario #2. Commissioner Taylor stated he could see the meritt in both scenarios. M/DeVoy, S/Taylor to go with scenario #4 for the jail bond terms. 2-1 Waring opposed. Motion passed.

<u>Budget Update:</u> County Administrator Shackett stated there was no budget posted but the report does show the expenditures and revenue to date. Commissioner Waring asked if the TAN funds had been received. Accounting Manager Lori Sharp stated they had.
