<u>Award courthouse window bid-Dustin Muzzey:</u> Facilities Manager Muzzey recommended awarding the courthouse window replacement bid to Bauen Corporation. M/Waring award the contract for the window curtailing replacement to Bauen Corporation and authorize the County Administrator to sign the contract, S/Taylor. Unanimous. **Motion passed**.

<u>Departmental Update-Nursing Home:</u> Nursing Home Administrator an update on her department. The Board was in agreement with her recommendation to purchase equipment for the kitchen. Nursing Home Administrator Richardson explained a new onsite LNA training program. Various questions were answered in regards to the program and the reason behind the vacancies. <u>Other:</u> Commissioner Waring asked if the employees that plow attend the driver safety program at Primex. Facilities Manager Muzzey stated they have not but would look into it.
