Cliff Matthews opened the RDA meeting. Cliff presented information relative to the proposal. The Planning Board required a series of small red maple trees to be planted on the condo access road entering off Mechanic Street for a visual and sound barrier. The trees are struggling. The applicant has requested they be permitted to trim back a series of white pines growing behind the maples. Additionally, the representatives have agreed to rip rap the area where a roof drain leader has minor erosion at the discharge point. Cliff added to the Conditions that all cut materials must be removed. In the future, the owners may trim the white pines if they grow into areas which may cause safety issues. Neal Standley moved to close the hearing and sign the RDA, seconded by Shawn Wade and passed on a unanimous vote. Note: Conservation Commission member Brian Norton did not participate in the hearing or sign the RDA, because he is a resident of Crystal Springs Condos.

Updates:

<u>1 Hartford Avenue hearing</u>: – at the June 22 Conservation Commission meeting, the hearing was closed, on a motion made by Michael Roche, seconded by Shawn Wade and approved by all 4 of the members attending that meeting. Only the members attending the meeting, and voting to approve closing the hearing, signed the order of conditions (Michael Roche, Shawn Wade, Brian Norton, and Cliff Matthews).

Kinder Morgan pipeline – the Northern Mass. pipeline proposal has been withdrawn. There is building opposition to these proposed gas pipeline projects by concerned parties. There is a new proposal locally with Algonquin/Spectra Energy. They're upgrading existing pipelines from outside New England and constructing new feeder lines including one from Medway to Braintree. Some work would be done in Bellingham. Cliff Matthews passed out a handout regarding how to regulate the work which is proposed in the Hartford Avenue/Medway line area. They will need permits. Cliff Matthews suggested to the representatives they come to a Conservation Commission meeting and make a presentation relative to activities proposed in the buffer zone. Cliff Matthews received a voicemail saying they were not coming to the meeting this evening. He will call back and inform them that the Conservation Commission wants a presentation, as this is new construction. It will be scheduled at an appropriate time.

<u>Open Space & Recreation Plan</u> – the previous plan expired at the end of June. Cliff and Anne Matthews never received notification but our Open Space planner/ consultant Gino Carlucci did (and he notified us of the expiration). We have received a report on the results of the citizen survey taken for the open space & recreation plan. This information will assist in drafting an updated version for the new Open Space & Recreation Plan in Bellingham.

<u>Pearl Street demolition</u> – The Conservation Commission requires a schedule for the demolition. The only permit on record governing the demolition is the commission's Order of Conditions. Cliff will notify the contractor of this requirement. He met with the new building inspector about it.

<u>Maple Street roadwork</u> – from Camp Bow Wow to the Charles River Bridge – Conservation Commission reviewed plans informally for cutting trees & drainage improvements along the road. The hearing will be scheduled for our next meeting and there will be numerous issues to address. This is a part of the town roadway improvement plan.

Michael Roche moved to adjourn the meeting at 8:50 PM, seconded by Neal Standley and passed on a unanimous vote.
