Bob Poxon discussed his conversations with Natural Heritage permit, they feel comfortable with the recommendations and hope to approve and give a certificate. Cliff Matthews noted from the Division of Fisheries and Wildlife letter, that there were two endangered species on the site – Eastern Box Turtle and Red Marble Salamander. He recommended that the hearing be closed and the Conservation Commission issue an order of conditions. Mike O'Herron asked about training for the developer's crew, to recognize and protect the endangered species. Cliff stated that they would need to go to classes and will be required to follow the Division of Fisheries and Wildlife lead at the project site. The elevation of cutting of trees by the basin was resolved in the last meeting, however Mike O'Herron stated the minutes for that meeting didn't reflect it. That issue is clearing up tonight. Cliff entertained a motion to close the hearing which was made by Mike Roche, seconded by Shawn Wade, and passed on a unanimous vote.

She was informed that all buildings but the Quonset hut (because is not part of the main structure), would be demolished. Cliff Matthews explained to the abutters present, with the plans, what was being removed (after hazardous material abatement was completed). The project will be put on the annual town meeting, if it can be prepared for presentation in May. We will issue a permit & if it doesn't pass at the town meeting, it's valid for three years. The Conservation Commission will be recommending this project at town meeting. A motion to close the hearing, issue the order of conditions and sign the order was made by Mike Roche, seconded by Neal Standley, and passed with a unanimous vote.

Kendra White from BETA made the presentation. There are 2,300 feet of water line to be installed. It will be a 12 inch water main to Lakeview Avenue. Wetlands at the solar array have already been submitted. Don DeMartino, DPW director stated it spent on the town master plan for a very long time. It needs to be done prior to the solar array construction in that area. Mr. DeMartino suggested the ideal timing would be for the solar array company to clear the land and then he would go out for bid for the water line project two weeks prior to their completion of the clearing. It would take proximally three days to the construction. There will be 5 feet of cover over the pipe which would be a polyethylene wrapped metal piping. Kendra stated that although they were not in the buffer zone they will put erosion controls on both sides of the road – there will be gate valves every 2,000 feet. The work will be done within an existing gravel exit road. She stated there would be a detail for dewatering with hay bales. Test pit logs will be given to the Conservation Commission. Neal Standley inquired about construction traffic – was told there would only be two trucks involved. Fill will be placed 6 inches below and above the pipe and then the excavation is backfilled. Access materials not used will be taken out or become property of the contractor. Ms. White provided the test pit reports at this time. Don DeMartino stated he was not worried about the gravel road being destroyed; which Michael Roche had questioned.

Cliff Matthews entertained a motion to close the hearing and issue a negative determination which was moved by Mike Roche, seconded by Mike O'Herron, and passed on a unanimous vote.
