Mr. John Foy, representative of the United Camera Co. of Providence demonstrated the Aridmatic Thermo-Copy Machine to the board members who found that this type of machine was not satisfactory because it could not reproduce certain inks.

The board signed the linen for "CHARLESGATE AT BELLINGHAM", which plan was approved on November 15, 1966. No appeals have been taken. Motion to sign the plan was made by Corriveau, (2) by Andrews. Vote unanimous.

Minutes of the previous meeting were approved as read by the clerk on a motion of Beauregard and (2) by Corriveau. Vote unanimous.

Board members agreed to meet at an informal meeting on Wednesday, December 14, 1966 at 8:00 P.M. to review the proposed changes to the Zoning By-Laws in preparation of presenting them in their final state at Public Hearings.

Board members discussed possibilities of accepting the following streets: KATHY DRIVE, DEERFIELD LANE, TEMI ROAD, RUTHELLEN, STELLA, PAUL ROADS; CAROLINE, SHEILA and ANN-MARIE DRIVE, SHIRLEY, PORTER, THERESA, MAUREEN, LISA ANN, PATRICIA, DONNA, YVONNE, JEANNINE ROADS; Extension to Harper Boulevard which includes CANDACE DRIVE, COUNTRY WAY; PLYMOUTH ROAD to the river and VALLEY VIEW.

The acceptance of Phillips Drive and Bruce Road to be further discussed.

A second inquiry form has been received by the board on a \$9,000.00 Bond re Sacco Construction Company. The board has no information concerning this bond and will request information from Jerome Sacco.

Budgets Sheets for next year are being prepared by the board.

A bill for the Norfolk Reg. of Deeds in the Amount of \$4.05.

Zoning Maps were discussed and the board reviewed the
Proposed Zoning By-Law Section on Definitions.

Chase suggested that the board purchase a coat rack. There
were no objections.
