Meeting of August 15, 1968.

Meeting was called to order by the chairman at 8:10 P.M. Minutes of the meetings of August 1 and 12 were approved as read by the clerk on a motion of Daigle and (2) by Parisi. Minutes of the meeting of August 14, 1968 were approved as read on a motion made by Parisi and (2) by Daigle. All unan.

On a motion made by Daigle and (2) by Parisi the board was unanimously in favor of signing the plan of Heritage Pines, 15 lots on Norma Circle for purposes of recording.

George Morin requested release of monies held in escrow by the Milford Savings Bank for completion of roads and utilities in Christine Road and Daniel Drive. On a motion made by Daigle and (2) by Parisi the board approved the release of \$5800.00 from Account #102905. The board requested that the bank continue to hold the remaining \$300.00 on deposit until minor repairs are completed in the roads as requested by the Highway and Water Depts. Vote was unanimous.

Robert Cournoyer, representing Campanelli, Inc. presented two Definitive Plans: Revised Wethersfield I on Patricia Road and Hartford Street containing thirty-seven (37) lots and Revised Wethersfield II on Arbend Circle, containing nine (9) lots. The chairman requested that Campanelli withhold the name of Patricia Road because of a duplication in the town. Public Hearing date was set for September 12, 1968. Motion made by Daigle and (2) by Parisi. Unanimous.

Cournoyer also presented two plans for Campanelli, Inc. Approval Not Required, one fronting on Hartford Avenue containing four (4) lots, the other containing seven (7) lots on Taunton Street. Prior requested the board withhold action on the two Form A plans until the next meeting of the board which will be held on 8/29/68, and would require a one day extension. Said extension granted to the board by Cournoyer. Motion to withhold action was made by Parisi and (2) by Daigle. Unanimous. Checks in the amount of \$40.00 for each form C were accepted from Cournoyer.

Plan of Victor J. Denault of one lot on Pulaski Blvd. was taken under advisement by the board until such time as the applicant could file a Form A with the board and Town Clerk. Motion was made by Daigle and (2) by Parisi. Unanimous.
