## October 12, 2011 Meeting Minutes Session prior to Town Meeting High School

PMM stated that while he is respectful of Mr. Ambler wanting to modify the parking bylaw, he would like to revamp all of the bylaw and not hurry it by creating mistakes. He would like to put it off until all of the bylaw is ready for Town Meeting and doing it right the first time.

DB reiterated PMM's comments about doing it right the first time.

Mr. Ambler stated that his proposed modifications will correct problems with restaurant parking. It is one small fix.
