Re: Request for approval of By-Laws

Gentlemen:

I hereby certify that the following amendment to the Zoning By-Laws and Map was unanimously adopted at the Special Town Meeting held April 5, 1968, under Article 5, of the Warrant:

Voted unanimously: to amend the Zoning By-Laws and Map by enlarging the size of the existing business zone which is located at the junction of Hartford Avenue (southerly side thereof) and North Main Street (westerly side thereof), which is presently designated as 1900 feet southerly along North Main Street and 600 feet westerly and parallel to North Main Street, so that as amended, said zone will be designated as 1900 feet southerly along North Main Street and 800 feet westerly and parallel to North Main Street.

I further certify as follows:

- 1) That the Warrant for the above Special Town Meeting was posted in at least one public place in each precinct at least fourteen days before said Meeting, in accordance with Town By-Laws. (March 22, 1968)
- 2) That the required quorum was present at all times at the above Meeting.
- 3) That notice of the ~~excess~~ hearing on the above amendment to the Zoning By-Laws and Map was posted in each precinct, and that said notice was published in the Milford Daily News and in the Woonsocket Call on February 13, 1968 and on February 20, 1968.

- 4) That the hearing above referred to was held on February 28, 1968 at 8:00 P.M. at Town Hall, Bellingham, Mass.

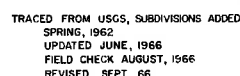
