

September 10, 2007

The regular meeting of the Board of Selectmen was called to order by Chairwoman Odabashian at 7:00 PM with all members in attendance except Mr. Martinelli.

Mr. DiMartino announced that the milling of North Main and Depot Streets will begin on Sept. 13th. The reconstruction of the Lake Street culvert between Cross and Railroad Streets will begin on Sept. 24th.

Mr. DiMartino also stated the water supply system tanks have dropped below typical levels over the last few weeks due to unseasonably hot late summer weather and a few mechanical problems that have been repaired. He noted the levels should rise with the rain predicted this week.

Public Hearing – application of Taylor Donuts, Inc. d/b/a Dunkin' Donuts for a Common Victualler License, 1 South Maple St.

Mrs. Odabashian read the public hearing notice. Neil Falkner represented Dunkin' Donuts. Board members asked what the hours of operation would be and when deliveries would take place. Mr. Falkner stated the establishment would be operating from 5:00 AM – 10:00 PM seven days a week. He noted the first delivery of the day would be at 3:00 AM and the second delivery about 10:00 AM.

Mrs. Odabashian asked if there was anyone present in favor or in opposition to this application. No one responded.

On a Goodnow/Picard motion, the Board unanimously voted to close the public hearing.

On a Goodnow/Picard motion, the Board unanimously voted to approve the application of Taylor Donuts, Inc. d/b/a Dunkin' Donuts for a Common Victualler License with hours as noted.

On a Goodnow/Davies motion, the Board unanimously voted to approve the minutes of August 13th as submitted.

On a Picard/Goodnow motion, the Board unanimously voted to approve sewer abatements in the amount of \$81.62; water abatements in the amount of \$322.74 and trash abatements in the amount of \$1052.00.

Public Hearing – application of MPG Corp. d/b/a Rapid Refill #123 for a Common Victualler License, 207 Mechanic St.

Mrs. Odabashian read the public hearing notice. Mr. Peter Garrett, Pres. of MPG Corp. stated this license is being requested strictly for D'Angelo's which will be operating at this location. Board members asked about operating hours and deliveries. Mr. Garrett stated D'Angelo's will operate seven days a week from 10:00 AM – 10:00 PM. He stated deliveries will be made at the rear of the building during off-peak hours, such as 3:00 PM.

Mrs. Odabashian asked if there was anyone present in favor or in opposition to this application. No one responded.

On a Picard/Goodnow motion, the Board unanimously voted to close the public hearing.

On a Picard/Goodnow motion, the Board unanimously voted to approve the application of MPG Corp. d/b/a Rapid Refill #123 for a Common Victualler License with hours noted.

On a Picard/Davies motion, the Board unanimously voted to approve a Common Victualler License for St. Brendan's Fall Fair, Nov. 3rd & 4th with fees waived.

On a Picard/Goodnow motion, the Board unanimously voted to adjourn the meeting at 7:35.
