Soil Board Public Hearing	<p>- Public Hearing regarding a Soil Board permit for 180 R Bayview Avenue as posted on May 10, 2018</p> <p>Mr. Vaz spoke about his concern that Pontes keeps saying that he has no idea how long it will take him to dig out for the septic and he has no idea how much dirt he will remove. And that he feels he has already taken more than enough to accomplish his goal. Vaz presented photos to the Board of the property taken in 2004. Miller read the following added conditions to the approved permit:</p> <ol style="list-style-type: none"> 1. This approval is for this Board only and does not determine if further approval is required from other Boards. 2. Order of Conditions apply to this permit. A copy of the Order of Conditions is attached to this permit. (Attachment 'A') 3. The provisions of the Agreement between the Town of Berkley Soil Conservation Board and Gilbert Pontes dated March 7, 2018 shall apply to this permit and are attached hereto and incorporated herein by reference. 4. No soil alteration and/or removal shall be conducted for the installation of a foundation unless a valid and current foundation permit issued by the Town of Berkley Building Inspector is in effect. 5. No soil alteration and/or removal shall be conducted for the installation of a septic system unless a valid and current Disposal System Construction Permit is in effect. 6. This permit is granted in conformity with statues and by-laws relating thereto, and expires on August 8, 2019, unless sooner suspended or revoked. New Business

- The board read aloud a letter of reorganization form the Berkley Finance Committee.
- The Board read a letter from Ed Dugan from the Berkley Cable Advisory Board. Miller stated that he would like to have Kerry speak with Ed Dugan to address the matters in his letter and if there are any bills that are not getting paid have her sign to pay for the bills on behalf of the Board of Selectmen. Also think that if Ed would be so kind as to reach out to the individual needed to repair the control booth and give him the authority to do that. Sterling noted that we should add something to the next agenda to discuss how to go about these matters since they are a part-time Board and they can't take on a full-time role and expect to get out the transparency that they would like to. There needs to be a Board or Committee that can be dedicated to making it happen. Miller asked Dugan in regards to his letter approximately how many bills a month was he talking. Dugan replied he would assume it was just normal bills like electric bill and the Comcast bill. Miller then stated that since it's only a couple bills a month then hopefully Kathy will be willing to take that over temporarily so the bills get paid. Jeanne Russo asked Miller to read the letter aloud.
- Miller read aloud a letter from Choate Hall & Stewart LLP regarding donation of \$21,000 to purchase a LUCAS CPR Machine. Miller noted that no one had gone out to solicit this. Miller thanked the gentleman on behalf of the Town for his donation. Miller feels it is a reimbursement rather than to purchase it. Cochrane stated that the Fire Chief spoke to her earlier and it was her understanding that they already purchased one and they were going to purchase another with this donation. And that this should not look at this as a reimbursement. Miller stated he would like the Fire Chief to come in to discuss this.
- The Selectmen reviewed a new Business Certificate for Legit Life Saving Lessons.
- Affidavit of Plan Distribution from Berkley Planning Board regarding definite subdivision plan of land on Ricardo Way was reviewed by the Board.
- The Board reviewed a notice from DEP regarding license application pursuant to M.G.L. Chapter 91 Waterways License Application Number W18-5273 Marcus & Taunya Baptiste.






