#### PUBLIC HEARING - October 21, 2013

Mayor Grenier opened the duly advertised public hearing portion of the meeting at approximately 7:50 p.m. to hear public comments on the following subject matter:

- Resolution 2013-23 Authorize CDBG \$12,000 Feasibility Study for Food Cooperative in Berlin Berlin Development Director, Pamela Laflamme, had informational packets available prior to making the following presentation:

Community Development Block Grant funds are available to municipalities through the NH Community Development Finance Authority. Up to \$500,000 annually is available on a competitive basis for economic development, up to \$500,000 for public facility and housing projects, up to \$500,000 for emergency activities that directly benefit low and moderate income persons, and up to \$12,000 is available for feasibility study grants.

The purpose of this Community Development Block Grant funding request: This is a proposed application to the Community Development Finance Authority for up to \$12,000 in Community Development Block Grant feasibility study funds to determine if there is a market for a food cooperative in Berlin. The funds, approximately \$12,000, will be sub-granted to WREN (Women's Rural Entrepreneurial Network) to hire a consultant to perform a market study to determine if there is a need and a market for a food cooperative in Berlin, NH.

This project conforms with the City of Berlin's Housing and Community Development Plan's Goals to reverse long term economic deterioration through expansion and diversification of the economic base of the Berlin area.

Mayor Grenier asked for public comments at this time. There were no public members present.

# Mayor Grenier closed this portion of the Public Hearing.

#### Mayor Grenier then opened the next Public Hearing

Berlin Development Director, Pamela Laflamme gave a review of the updated <u>Housing and</u> Community Development Plan.

The plan is the same plan accepted by the City Council in January 2013. Complete copies of the plan are available for review in the Community Development Department.

Mayor Grenier asked for public comments at this time. There were no public members present.

# Mayor Grenier then opened the next Public Hearing

Berlin Development Director, Pamela Laflamme gave a review of the <u>Residential Antidisplacement</u> and <u>Relocation Assistance Plan.</u>

Although this project does not involve any displacement or relocation of persons (or businesses), if the City were to undertake a CDBG project which involved displacement or relocation they would follow this plan. The plan outlines the measures they would take to find comparable, suitable housing for persons (or businesses) displaced or relocated.

Whereas all grant proceeds shall be deposited with the City Treasurer and that any additional use of these funds beyond the scope of work as listed in the application shall require prior approval of the City Council. Now Therefore Be It Resolved by the City Council of the City of Berlin as Follows: That, the City Manager is authorized to apply to the Community Development Block Grant Feasibility Study Program for \$12,000 on behalf of Women's Rural Entrepreneurial Network (WREN) for funds to study whether there is a market for a Food Cooperative in Berlin, NH and upon approval of said application, the City Manager is authorized to execute any documents which may be necessary to effectuate the CDBG contract. This Resolution shall be in full force and effect from and after passage.

Councilor Nelson moved with a second by Councilor Theberge to remove the resolution from the table at this time. So moved, the motion carried.

Councilor Nelson moved with a second by Councilor Theberge to amend the resolution by replacing the words "a local nonprofit organization" with "Women's Rural Entrepreneurial Network (WREN)" as presented. So moved, the motion carried.

Councilor Nelson moved with a second by Councilor Theberge to have the resolution, as amended, read a second time by title only. So moved, the motion carried.

Councilor Nelson moved with a second by Councilor Theberge to have the resolution, as amended, read a third time by title only. So moved, the motion carried.

Councilor Nelson moved with a second by Councilor Theberge to pass the resolution, as amended. So moved the motion carried and Mayor Grenier declared the resolution, as amended, now passed.

Councilor Higbee moved with a second by Councilor Rozek to adopt the updated Housing and Community Development Plan. So moved, the motion carried.

Councilor Higbee moved with a second by Councilor Morgan Allain to adopt the Residential Antidisplacement and Relocation Assistance Plan. So moved, the motion carried.

Councilor Morgan Allain moved with a second by Councilor Otis to approve the submittal of the application and vote to authorize the City Manager to sign and submit the application, and upon approval of the CDBG application, authorize the City Manager to execute any documents which may be necessary to effectuate the CDBG contract.
