- Marijuana Regulations.

  - o Requesting a 3 foot offset to ledge. Local regulation requires 25 feet. Title 5 has no offset requirement to ledge.

- 435 Main St. Title 5 discussion.
  - Seller is requesting that they not have to do a Title 5 inspection because the last one was done three years ago and they pumped the system once each year. The State doesn't include pumping done during the Title 5 inspection.
  - o Upon review of the pumping records provided, the Board discovered that the pumping was not done within a consecutive 12 month period from recent inspection date, therefore they don't gain the extra year.
