EDC-Main Street Sewer District

- Based on their understanding of a potential septic issue on Main Street they would like the Board's view on the actuality of the situation and potential options for addressing it. H. Demmer brought a map to display buffer zones which might highlight existing or potential problem areas.
- The committee would like to explore the possibility of utilizing the waste water treatment facility at Florence Sawyer School to address the situation in a proactive way to increase economic viability in the downtown corridor and help the property owners. The goal would for the project to self fund with users paying to utilize the system. The appeal to the rest of the town is the income generated by usage fees, property value increases and the general hope to modernize and improve the main street area.
- Board questioned if the entire system that was planned has been built. Committee will investigate. .
- C. Slade reported that a public document appoints the Board of Selectmen to act as the public sewer . commission if the need arises and until a commission is devised.
- Another possibility being investigated by C. Slade is to create a system on the conservation area that would be a condominium system that could be funded by the properties currently having issues.
- The Board can pull together a written report for the committee with a list of homes with upgraded • systems and homes with Title 5 Inspections.
