4. ANNEXATION APPEAL

WHEREAS, on March 11, 2014, the Village Board adopted Findings, Resolutions and Order pursuant to General Municipal Law (GML) Article 17 determining that the proposed annexation of the 17/20 Area, as defined therein, "is in the overall public interest" and thereby approved the Village's annexation of said portion of the unincorporated Town of Ossining; and

WHEREAS, on March 11, 2014, the Town of Ossining adopted Findings, Objections and Determination on the subject of the annexation by the Village of the 17/20 Area, and concluded that "annexation will not be in the best interests of the Town of Ossining"; and

WHEREAS, in accordance with the GML, the Village and Town each filed their respective determinations with their own and the other's municipal Clerk; and

WHEREAS, GML Article 17 provides for the adjudication of the issue of annexation where one municipality approves annexation and another denies approval thereof.

NOW THEREFORE BE IT RESOLVED that Village Counsel is hereby directed to take all requisite actions to commence and maintain proceedings, in accordance with GML Article 17, to seek adjudication and determination from the Appellate Division of the Supreme Court of the State of New York, on the law and facts, of the issue of whether the proposed annexation is in the over-all public interest.
