Approval of Minutes:

Mr. Brown made a motion to approve the Board of Selectmen Meeting Minutes from March 8, 2016, Mr. Brown seconded. All in favor, motion carries.

Public Comment:

Ned Bandler addressed concerns regarding the posting of agendas for Board of Selectmen meetings in a timely and well publicized manner. Mr. Bandler also asked that the selectmen keep aware of some of the legislative issues in Hartford that can impact the town potentially.

Carolan Dwyer – Burnham PTO requested the Town's assistance in the purchase of a sign announcing open enrollment at the school and that it is a school of distinction (see attached).

Mr. Brown made a motion to pay for half the sign (estimated \$250), seconded by Mr. Read. Discussion. Mr. Null said he would prefer to learn more about the specifications and design of the sign, Mr. Brown and Mr. Read concurred. All voted against, motion does not carry.

Capital Improvement Plan:

See attached. Mr. Read continued discussing with the selectmen a capital improvement plan for the Town. It includes rebuilding the Grange, installing sidewalks in the center of Town, and other town owned building improvements.

FY17 Budget Overview:

The selectmen discussed the development of the 2017 Fiscal Year budget. The ACE program requested funding from the Town to help support the program (see attached). Mr. Brown made a motion to grant ACE \$10,000 for operation assistance for the 2017 fiscal year, seconded by Mr. Null. All in favor, motion passes.

Organics Program:

The selectmen discussed various options in order to sustain the organic waste program in Town. No action taken.

Oil Tank Removal Update:

Mr. Read stated that the oil tank at the Peck House was removed and the contaminated soil was remediated satisfactorily. He also stated that several other oil tanks were removed successfully on town owned properties.
