**Call to Order:** The meeting was called to order at 7:30 p.m. by Chairman Bob Kelly.

**Minutes of the regular meetings held May 18, 2010 and June 15, 2010:**

G. Bollard made a motion to approve the minutes of the regular meeting of May 18, 2010. L. Franklin seconded. G. Bollard, S. Purdy, A. McNaughton, L. Franklin, F. Sproviero, D. Fitch were in favor. B. Kelly abstained.

B. Kelly verified that the minutes for the meeting held on June 15, 2010, were accurate. A. McNaughton made a motion to approve the minutes of the regular meeting of June 15, 2010. G. Bollard seconded. G. Bollard, S. Purdy, A. McNaughton, L. Franklin, F. Sproviero, B. Kelly were in favor. D. Fitch abstained.

**New Business:**

B. Kelly asked that the order of the applications be switched.

1. Denning, 678 Main Street South, barn. Tammy Zinick presented the application to the commission as representative of the applicant. The applicant is proposing to reconstruct the existing barn. He will be moving it back seven feet to the existing foundation. The commission members would like the map to be updated to include silt fence, construction barriers, stockpiling, construction sequence, utilities, topography, abutters, existing and proposed contours, driveway, entrance to the barn, elevations and distance from an intermittent stream. A. McNaughton, D. Fitch and F. Sproviero will be case officers.

1. Kelly/Brill, 99 Lake Lillinonah Drive South, new dock. B. Kelly recused himself. F. Sproviero will chair the meeting for this application. B. Kelly asked the commission to decide whether or not he needed a permit. He is proposing to attach a floating dock to brackets that will be attached to the existing wall. G. Bollard felt the enforcement officer could handle this. K. Vaughn said he would need to see a plan. A. McNaughton made a motion to authorize K. Vaughn to sign off on this application as enforcement officer. S. Purdy seconded. Unanimous approval.

B. Kelly returned as chair.

**Enforcement:** K. Vaughn present his report to the commission. He received a complaint concerning tree cutting on Tappan Road. Five to six acres of trees had been cut. K. Vaughn will meet with property owner George Allingham and his engineer at the property.

Region 12 has changed their plan for the drainage at Burnham School. They will be regrading the parking lot and the proposed drainage will not be necessary. The commission felt this was a right of maintenance.
