Minutes of the regular meetings held July 20, 2010:

G. Bollard made a motion to approve the minutes of the regular meeting of July 20, 2010. F. Sproviero seconded. Unanimous approval.

Old Business: none

1. Denning, 678 Main Street South, barn. B. Kelly reported that A. McNaughton had notified him that the materials requested were not ready. This item will be tabled until the next regular meeting.

New Business:

S. Purdy asked the commission if they felt that he would need a permit to repair the drainage on his driveway. The commission felt that this was a right of maintenance.

Enforcement: K. Vaughn presented his report to the commission.

1. Tappan Road, Allingham, clear cutting. K. Vaughn met with property owner George Allingham and his engineer Paul Szymanski at the property. There was no continuous slope of 15% or more to a wetland. The clear cut area was not more than 5 acres. K. Vaughn felt there was no violation. There was however a trail on his property that was in violation and he will need a permit to repair it. B. Kelly will contact the property owner and let him know that the commission will be expecting an application.

2. Trail on Peardon and Coleman Properties. K. Vaughn reported on a trail that had been constructed on the Peardon and Coleman properties on Hemlock Road. He recommends that a cease and desist be sent to both property owners. C. Read asked if this trail was for an agricultural use. K. Vaughn felt it was used for horses and they were not more than a week old. C. Read suggested that the commission contact the property owners and inform them that the commissioners would like to go on the property. B. Kelly will contact them. D. Fitch felt that due process should be followed. G. Bollard said that the landowners should submit a plan to the commission

Procedural Matters: The commission thanked Keith Vaughn for his years as Wetlands Enforcement Officer. Russ Dirienzo from Roxbury will be the new Enforcement Officer.
