Old Business:

1. Miscia, 300 Rocky Hill Road, boat house. G. Bollard had already been to the property. He reported on his site visit. He felt the hardest part of the project would be access since the boat house is in the lake. B. Kelly asked if the boat house had to be floating. G. Bollard explained that the boat house as it is now is grandfathered because it is preexisting. It will be in the same footprint. T. Seger was present representing the applicants. He explained that the boat house had been damaged by the storm in the fall. The boat house is gone and the footbridge to it needs to be repaired. The boat house and the footbridge will need to have 10 pylons. He had been in touch with Brian Wood from First Light. There will be an extended draw down of the lake so the work is planned for that period. He also explained that there is a catch basin above the dam wall that needs to be cleaned out which will help protect the area during construction. Water will need to be rerouted around the area during the work period. There was power and water to the structure but it is all shut off now. Everything that is there will need to be removed and rebuilt starting from scratch. G. Bollard, L. Franklin and F. Sproviero will be case officers. They plan to meet with Brian Wood and an engineer at the site as well.
