#### **Old Business**:

1. Dizengoff, 3 Landmark Drive, rebuild retaining walls. Louis Fusco, Landscape Architect was present for this application. He presented revised plans to the commission. He proposed to clear the woods and do some planting mitigation. He also presented a revised plan for the lake walls and a sequence of construction. G. Bollard reported on his site visit. He was satisfied with the proposed mitigation. It showed a better management of surface water flow. The draw down of the lake will be October 30 to November 15. The stabilization of the shoreline will be done during that time. G. Bollard made a motion to approve the plan for Betsy and Ira Dizengoff according to plan ECI last revised 9/12/2013, and SP1 according to general provisions and working closely with the Wetlands Enforcement Officer. C. Read seconded. The temporary road and staging will have to be done ahead of time. Unanimous approval.

2. C. Read submitted details for the bridge repair on Eabow Brook Road.

#### New Business:

1. Dizengoff, 3 Landmark Drive, addition. The project includes a new garage and alteration to the house. E. Vikstrom and F. Sproviero will be case officers.

2. Clatter Valley, footbridge. Nicholas Ferlow presented this application to the commission. He is proposing repairs to an existing footbridge which will include a retaining wall, replacing a concrete slab under the bridge, redirecting the stream to correct erosion and controlling the velocity of water with as much rock and stabilization as possible. This project was found to be routine maintenance.

3. Buzzeo, Eabow Brook Road, driveway. Brian Neff, P.E., presented this application to the commission. A. McNaughton, B. Kelly and L. Franklin will be case officers.
