**Call to Order:** The meeting was called to order at 7:30 p.m. by Chairman Frank Sproviero. The meeting was being recorded.

**Minutes of the regular meeting held February 18, 2014.**

J. Lindblom made a motion to approve the minutes of the regular meeting held on February 18, 2014. A. McNaughton seconded. Unanimous approval.

**Old Business:** none

1. Slastushinskiy, 45 Lake Lillinonah Drive North, pool, patio, retaining walls. Scott Williams was present for this application. He submitted an updated map to the commission. The pool does not have to be backwashed. It will be drained through a garden hose. A level spreader is being proposed and the pool drainage as well as the house drainage will go through the level spreader. The proposed start date for this project will be May 1, 2014, and will take about 3 – 5 months.

The sequence of construction will be:

1. remove the shed
2. install erosion control
3. excavate
4. stockpile
5. create the level spreader
6. tie in drainage
7. construct veneer walls
8. install pool
9. install stairs
10. build the patio
11. install railing
12. planting design

F. Sproviero made a motion to approve the application for the Slastushinskiy property, 45 Lake Lillinonah Drive North, as per drawing 05-043, by DiVesta Engineering titled As-Built Proposed Pool and Fence, dated 12-11-13. E. Vikstrom seconded. T. Seger, S. Purdy, E. Vikstrom, J. Lindblom, A. McNaughton and F. Sproviero were in favor. V. Nelson abstained.

2. Allen/Mendlin, 409 Northrop Street, dock. Brian Neff was present for this application. A. McNaughton and V. Nelson reported on their site visit. The applicants will use a small Kabota to bring materials to the site. They will dig out only as much as they need to put in an anchor block for their free floating dock. A. McNaughton approved the application for a lakeside dock for Timothy Allen and Kevin Mendlin, 409 Northrop Street, as per plan by Brian Neff dated 1-20-14, sheet 1 of 1. V. Nelson seconded. Unanimous approval.

**New Business:**

1. Kinnicutt, 232 Clapboard Road, clearing brush. Michael Kinnicutt presented his application to the commission. He is proposing to clean up the brush around the pond and remove some of the silt that is coming from the road which has built up over the years. T. Seger and Louise Marble will be case officers.
