### **New Business:**

- 1. Dempsey, 15 Old Turnpike Road West, additions. David Dillon presented the application to the commission. He was representing Stephen and Patricia Dempsey. The applicants are proposing to put a bedroom and dining room addition and two decks on the existing house. T. Gilmore made a motion to approve the application. E. DeVoe seconded. Unanimous approval.
- 2. Berger, 197 Skyline Ridge Road, addition. Ron Cipolla presented the application to the commission. He was representing Mr. & Mrs. Berger. The applicants are proposing to put a master bedroom and master bath addition on the first floor of the existing house. T. Gilmore made a motion to approve the application. E. DeVoe seconded. She urged the commission to act on this issue.

L. Carreira reported that she and the Health Director met with Bill Stuart. B. Stuart felt that the file should be sent to the town attorney.

Discussion followed concerning the fact that the property could be considered an junkyard and a transfer station because they bring stuff in and then sell it.

T. Gilmore made a motion to send Mrs. Shanks a cease and desist stating that she is operating a junk yard. She needs to get rid of the garbage, the pod and vehicles that are on the property. If there is no response in two weeks the matter will be turned over to our attorney. E. Terry seconded. Unanimous approval.

The commission received a letter of complaint signed by several neighbors concerning noise, removal of material and storage of commercial vehicles on the property. J. Bandler made a motion to send a cease and desist and ask Mr. Southard to attend the next meeting and explain what he is doing to the commission. E. Terry seconded. Unanimous approval.

A letter was received from Attorney Mark Branse about a new Public Act concerning bonds for site plans and subdivisions. The commission members will take it home to read it and discuss it next month.
