Old Business:

- 1. Southard, 31 Stuart Road East, special permit application for removal of earth materials. Brendon Southard and Dainius Virbickas P.E., were present for this application. L. The applicant will be restricted to the time limits of activity stated in Section 5.03.06, of the Bridgewater Planning and Zoning regulations which are: "No activity connected with any excavation, removal, or filling operation may be undertaken (i) on any

Sunday or any legal holiday; or (ii) earlier than 7:30 a.m. or after 5:30 p.m. Monday through Friday; or (iii) earlier than 8:00 a.m. or after 12:00 noon on a Saturday."

The applicant has 90 days from the filing of this document to complete this project. A letter from an engineer certifying that everything has been completed and the accepted grade has been met will be required at that time. E. Terry seconded. Unanimous approval.
