#### **Old Business:**

3. Discussion of P&Z Regulations. J. Bandler asked the commission to consider accessory apartments, home businesses, senior housing, sheds, and generators.

As for accessory apartments right now we require double the lot size in that zone and 25% of the main house. C. Read had suggested having two structures connected with a breezeway.

E. Degrazia felt we should wait until there was a request for an accessory apartment.

W. Khare felt that the way it is now benefits larger houses and it would be good to loosen that up.

T. Gilmore thought an apartment should be at least 1000 sq. ft.

D. Virbickas suggested allowing an attached apartment could be one bedroom and a detached two bedrooms.

E. Degrazia questioned the cost of building the additional structure and adding a septic system.

There was discussion about kitchens and allowing only relatives to live in an apartment.

J. Bandler said there was a group studying senior housing.

In the discussion about home businesses, J. Bandler felt that a home business did not have to be only on the first floor. T. Gilmore said that someone could have a computer, a phone and no employees and they wouldn't need a permit. It's people coming and going, making noise and parking that is the issue.
