Coordinator's Report: Program Enrollment reported, as of April 2015. Report Approved

Old Business:

- Red Shed Bathrooms: Broken into, door broken, toilets demolished, generalized clutter.
- Pavilion Job: Eric Soetbeer recommended Tom Ascenzi for the position of overseer of the Pavilion, meet with prospective renters, open facility and close facility. Tom Ascenzi met with the Commission to discuss position. Commission has determined that a flat fee of \$35 per opening and closing would be appropriate, whether it takes a minimum of 1 ½ hours or 2 hours. Tom was given job description and was hired to do the job. The administrative part of the position will be handled by Ann Virbickas until a new person is hired. Catherine Vikstrom will advertise for the position.
- Program Update: Pickle ball began Monday April 20, 2015, Densh Rajagopalan of the New Milford Swim and Tennis Club was in attendance to lend a hand to instruct participants on the finer points of the game. Not all those who had signed up came, but there was a decent turn out. Easter Egg Hunt at Burnham School was a success, and Yoga has full enrollment for July, for the 1st time.
- Fishing Derby: Mike Dubos is in charge. Derby is Saturday May 2nd, fish have been ordered and will be delivered by Rowledge Farm Aquaculture. New Business:


- PTO request for one week of summer camp free for their auction. Request was approved.
