- 7:00 PM Enforcement Order (EO): Haynes Hill Road (Assessors) – Chris Batista**
Violation at Haynes Hill Road (Assessors Map 17 A 2.1). 3 excavators parked on associated property and a neighboring property (Assessors Map 17 A 3). The equipment is located within wetland resource areas and is reportedly leaking petroleum products into said resource areas. Pursuant to a site inspection conducted on October 30, 2013, approximately 150-square feet of significant disturbance to the resource areas from direct vegetation cutting and removal, soil disturbance, compaction and rutting, and changes to the natural hydrologic regime from heavy equipment moving throughout the property were observed.

Specifically, the work includes the clearing and filling of 5,000 – square feet of wetlands for a 6-foot wide path. The proposed work lie within resource areas and the buffer zones regulated under M.G.L. Chapter 131, §40.

Notice of Intent (NOI) submitted by Roux Associates, Inc., c/o EXXONMOBIL Pipeline Company for the work at 229 Palmer Rd (Assessors Map 10E Lot 11), pertaining to the preventative maintenance activities for the ExxonMobil pipeline. Specifically, the work includes raising the stream bed by approximately 3-feet to reestablish cover over the currently exposed pipeline.
