7:00 PM Cont. EO/NOI DEP # 117-0325: 10 Shaw Road (Map 5 A-B Lot 15.1) –David Mayo

Notice of Intent (NOI) submitted by Greenhill Engineering c/o David Mayo for the work at 10 Shaw Road (Assessors Map 5A-B Lot 15.1), pertaining to proposed construction of a path to Little Alum. Specifically, the work includes the clearing and filling of 5,000 – square feet of wetlands for a 6-foot wide path. The proposed work lie within resource areas and the buffer zones regulated under M.G.L. Chapter 131, §40.

7:00 PM Request for Determination (RDA): 69 Cubles Drive (Map 6A Lot A-20) – Dolores Berry

Request for Determination (RDA) submitted by Dolores Berry, for work at 69 Cubles Drive, Brimfield MA 01010 (Assessors Map 6A Lot A-20), to determine if the work associated with the clearing of land and the removal of trees and shrubs is subject to the Wetlands Protection Act, M.G.L. Chapter 131, §40. The work associated with the tree removal will occur within the 100-foot buffer zone of Lake Sherman.

Request for Determination (RDA) submitted by Massachusetts Department of Transportation, Highway Division, District 2, for work along Interstate-90 Eastbound and Westbound (including entrance and exit ramps) beginning at the Palmer Town Line, proceeding easterly to the Warren Town Line (Westerly section), then from the Warren Town Line proceeding easterly to the Sturbridge Town Line (easterly section) to confirm and verify the resource area delineations for the application of herbicides

7:40 PM Cont. NOI DEP: Apple Road (Map 4E Lot 2) – Joe Ciesla

Notice of Intent (NOI) submitted by Waterman Design Associates, Inc c/o Joe Ciesla for the work off Apple Road (Assessors Map 4E Lot 2), pertaining to the crossing of a perennial stream for access to the rear of Lot 3 for future house construction. Specifically, the work includes the construction of a 12-foot drive and the installation of a 12' wide X 2.5' high X 28' long open-bottom box culvert. The proposed work alter 875 square feet of Bordering Vegetated Wetland and 19,850 square feet of the Riverfront of a perennial stream

8:00 PM Cont. NOI DEP # 117-0334: 229 Palmer Road (Map 10E Lot 11) – Exxon Mobil

Notice of Intent (NOI) submitted by Roux Associates, Inc., c/o EXXONMOBIL Pipeline Company for the work at 229 Palmer Rd (Assessors Map 10E Lot 11), pertaining to the preventative maintenance activities for the ExxonMobil pipeline. Specifically, the work includes raising the stream bed by approximately 3-feet to reestablish cover over the currently exposed pipeline. Portions of the proposed work lie within resource areas and/or buffer zones regulated under M.G.L. Chapter 131, §40.

8:20 PM Enforcement Order (EO) DEP # 117-0338: 145 Sturbridge Road (Map 14A Lot 21.3) – SH Solar2NE

Violation at 145 Sturbridge Road (Assessors Map 14A Lot 21.3), resulting from the construction of a 3.5 MW Solar Array. Specifically, the violation includes the non-compliance with the terms and conditions of the Amended Order of Conditions DEP # 117-0388, issued March 14, 2014. In particular, the work occurring at 145 Sturbridge Road has created excessive sedimentation that is now eroding into resource areas protected under the Wetlands Protection Act (WPA).

8:40 PM Enforcement Order (EO): 46 St. Clair Road (Map 11A Lot 2) – John & Sarah Rahkonen

Violation at 46 St. Clair Road (Assessors Map 11 A 2). The work occurring at 46 St Clair Road has altered an area subject to protection. Approximately 250-square feet of disturbance to the Riverfront Area, Bordering Vegetated Wetlands (BVW) and bank resource areas Penny Brook (Assessors Map 11 A 2.5) has occurred from direct sediment laden runoff exiting 46 St Clair Road.
