## SENIOR CENTER/SOCIAL SERVICES

The December 3rd Holiday Boutique, that raised some \$3,000 for the Senior Center, was a big success. Ellen reported that 145 clients took advantage of the consultation appointments for Medicare Part D. The Red Cross has partnered with the Senior Center and the Brookfield Volunteer Fire Department to conduct a Home Fire Preparedness Campaign. They are offering new smoke detectors for those who sign up at the Center. The YMCA is leading a diabetes prevention program at the Center. Meeting at the Senior Center is The Brookfield Cares Support Group and the Alzheimer's Support Group. Meeting times can be found in the Senior Center's monthly newsletter. Planning for 2017 trips is underway; some of which sell out quickly. Lorraine Kelly, Social Services Coordinator, has information on the Energy Assistance program that has started. Thirty-Nine families received Thanksgiving baskets which served 159 individuals. Seventy-five children in 40 families had a brighter holiday thanks to the generosity of Brookfield residents.
