- a. Capital Project Status Review
  - i. **<u>Brookfield High School</u>** First Selectman Davidson stated that this project is still in litigation.
  - ii. <u>Senior Center</u> First Selectman Davidson stated that minor repairs need to be done to finalized to complete this project.
- iii. <u>Roads</u> First Selectman Davidson gave an update on roads stating that the roads project is almost completed for this year.
- iv. <u>Kids Kingdom</u> First Selectman Davidson stated that bids for this project came in too high.

# **REPORT OF THE TOWN CONTROLLER:**

a. Financial Reports – Controller Wahlberg presented the Board with the preliminary June 2011 results. The books have not been closed yet as he is waiting for expenses that were incurred before or on June 30, 2011 that have not been recorded on the town books. He also stated that property taxes exceeded their estimate by 319,000. Controller Wahlberg also reported that the town has received \$51,000 from FEMA. Controller Wahlberg stated that under Expenses the Assessor and Town Counsel came in under budget. He also stated that pending budget transfers will be brought to the Board at the August 2011 meeting.

# **BOARD OF FINANCE COMMITTEE REPORTS:**

- a. Audit No report was given for the Audit Committee.
- b. <u>Bylaws and Procedures</u> Secretary Agard stated that the Bylaws Committee will meet with Controller Wahlberg to discuss how to best understand the 5-Year Capital Plan and its relationship to the annual budgeting process and long term cash flow.
- c. <u>Retirement Benefits Advisory Committee</u> Vice Chairman Belden stated the committee is down to choosing two candidates. A decision should be made within the next 30 days.
- d. <u>Charter Revision Committee</u> R. Jaffe clarified that the Charter Revision Committee is not

agendas should reflect committee reports under a different heading. R. Jaffe reported that he has been working with Chris Kukk from WestConn. Chris Kukk recommended an intern to conduct research for the committee and she will receive full credit. R. Jaffe thanks Chris Kukk
