<u>School 2013-2014 Year End Budget Update and Finances + Search Committee Update</u>: Chairman of the Board of Education P. Checco gave the Board an update of the school's 2013-2014 year end budget. Acting Superintendent G. Slone gave an update on the search committee.

<u>New Software Upgrades</u>: Town Controller W. Leverence reported upgrades to the Town's Munis System.

<u>High School Closeout</u>: Town Controller W. Leverence stated that the auditor will be at Town Hall the first week in July for the final review. When the final review is received it will be presented to the Board of Finance to be reviewed.

<u>Audit Update</u>: Town Controller W. Leverence stated Lauren Hill, Field Rep. Manager, from the audit firm McGladrey, is assigned to perform the Town's audit.
