**REPORT OF THE FINANCE DIRECTOR**: Town Controller W. Leverence gave the Board an overview of the Revenue & Expenditure Report for the month of June 2015.

## **NEW BUSINESS:**

- <u>Candlewood Fire Department Capital Items</u>: A motion was made by Vice Chairman E. Nepomuceno, seconded by Dr. R. Appleby, that the Board of Finance approves a reserve for unspent FY 2015 Budgeted Cash-to-Capital Fund of \$24,000 for the Candlewood Fire Co. Footing Drain Replacement project. Motion passed unanimously.
- <u>LOTCIP Grant</u> A motion was made by Secretary R. Gianazza, seconded by Vice Chairman E. Nepomuceno, that the Board of Finance approves a special appropriation of \$798,351 in LOTCIP Grant funds for Roadway and Streetscape improvements at the intersection of Route 202 and Route 25. Motion passed unanimously.
- <u>Still River Greenway</u> A motion was made by Secretary R. Gianazza, seconded by J. Rossi, that the Board of Finance approves an additional appropriation of \$396,000 for the Still River Greenway project approved by voters at the June 24, 2014 referendum. (The Board of Finance authorizes \$79,200

from the General Fund Balance, or in bonds, notes, and/or temporary notes of the town to finance the appropriation). Motion passed 4-1.
