

## REVISED BROOKFIELD BOARD OF FINANCE REGULAR MEETING MINUTES WEDNESDAY, OCTOBER 14, 2015 7:00pm BROOKFIELD TOWN HALL, ROOM 209

<u>CALL TO ORDER</u>: Chairman P. Kurtz began the meeting at 7:00pm; beginning with the Pledge of Allegiance.

**<u>PUBLIC COMMENT</u>**: There were no public comments.

<u>APPROVAL OF MINUTES</u>: A motion was made by Secretary R. Gianazza, seconded by Dr. R. Appleby, to approve the September 9, 2015 Board of Finance Regular Meeting Minutes as written. Motion passed unanimously.

**<u>REPORT OF THE FIRST SELECTMAN</u>**: First Selectman B. Tinsley reviewed the updated reconciliation between the school and Town for fiscal year 2014/2015 showing an unspent balance of \$274,000 by the school.

**<u>REPORT OF THE FINANCE DIRECTOR</u>**: Town Controller W. Leverence gave the Board an overview of the Revenue & Expenditure Report for the month of September 2015.

<u>MUNIS Update</u>: Town Controller W. Leverence stated the agreement has been signed by the First Selectman and the Superintendent of Schools. The kick-off meeting is next Tuesday with BlumShapiro.

## **OLD BUSINESS**

Continuation of the tabled motion and discussion for an Unexpended Funds non Lapsing Contingency Account requested by the Board of Education

This agenda item was tabled and will be placed on the November 11, 2015 Board of Finance Meeting Agenda. BOF waiting for final BOE 2014-2015 fiscal year end finances.

<u>Audit Update Reports</u>: Chairman P. Kurtz stated that the auditors are on-site through the end of the week. The preliminary report is expected by the beginning of November and the Board will review and approve the final audit report in December.
