

# BROOKFIELD BOARD OF FINANCE REGULAR MEETING MINUTES WEDNESDAY, DECEMBER 9, 2015 7:00pm BROOKFIELD TOWN HALL, ROOM 209

<u>CALL TO ORDER</u> First Selectman S. Dunn began the meeting at 7:00pm; beginning with the Pledge of Allegiance.
