CAFR Discussion

First Selectman S. Dunn introduced Janette J. Marcoux, Town's Financial Advisor. She explained the various options available to the Board of Finance, and recommendations from Bond Counsel.

FOIA Request by Resident Rich Saluga:

Chairman R. Gianazza stated that the Board of Finance continues to follow up on Mr. Saluga's FOIA request. First Selectman S. Dunn stated that he will supply the breakdown of the number of hours worked by attorney, at what rate, photocopying and transportation fees.

### **NEW BUSINESS**

### GrantFinder Program

A motion was made by Chairman R. Gianazza, seconded by M. Mulvaney, that the Board of Finance approve the recommendation of the Board of Selectman to acquire the GrantFinder Program for the amount of \$600.00 to be funded from the Town Controller's Education Account #011715290. Motion passes 6-0.

### Town Pension Plan

First Selectman Stipend in lieu of Pension and budget adjustment.

A motion was made by J. Rossi, seconded by M. Mulvaney, that the Board of Finance supports the recommendation of the Board of Selectman request for Resolution for Amendment No. 7 of the Pension Plan. Motion passes 6-0.

2. Motion: That the First Selectman receive a "Stipend in Lieu of Pension" equal to 6% of the previous year's actual base salary, payable in a lump sum at the beginning of each calendar year. This resolution shall be implemented effective December 8, 2015 upon the First Selectman taking office.

The Board stated that there is a conflict in wording – base compensation vs. base salary. First Selectman Dunn will confer with the labor attorney regarding wording.

Irv Agard, 3 Cedar Hill Road explained how the RBAC committee arrived at the 6% level of the stipend.

A motion was made by J. Rossi, seconded by Secretary S. Hathorn, to table this motion until the March Board of Finance Regular meeting.

<u>CCM Newly Elected Workshop</u> – February 20: First Selectman S. Dunn stated that any Board member who would like to attend this workshop contact Ginny Giovaniello, Administrative Assistant to the First Selectman. Chairman R. Gianazza will forward information on the workshop.

### **OTHER ITEMS TO COME BEFORE THE BOARD:**

M. Zerbe stated he would like the Board to follow its bylaws and produce an agenda one week before the meeting.

Chairman R. Gianazza stated an AdHoc committee should be formed to come up with other options of addressing the bonding issue. Members of this AdHoc committee are Chairman R. Gianazza, Town Treasurer J. Lucas. M. Zerbe, and First Selectman S. Dunn. The town's input is welcomed. Chairman R. Gianazza stated he would like to have a copy of the recommendations from the Town's Financial Advisor.
