- 2. Recycling Rewards Grant BK3 Truck: A motion was made by Secretary S. Hathorn, seconded by G. Rooney, to discuss the Recycling Rewards Grant BK3 Truck. After discussion, a motion was made by Chairman R. Gianazza, seconded by Vice Chairman J. Rossi, to approve the transfer of Bonded Funds from the line item for the \$220,000 dump truck and to reduce that line item by \$27,768 and create a new line for the recycling truck. Motion passes unanimously 4-0.
