# **NEW BUSINESS:**

1. <u>Meet new Purchasing Agent – Jerry Gay</u>: First Selectman S. Dunn introduced Jerry Gay as the new Purchasing Agent for the Town and Board of Education.

5. <u>4 Corners Streetscape Project Update – Greg Dembowski</u>: G. Dembowski gave the Board an update on the 4 Corners Streetscape Project.

- 3. <u>Planning Commission Letter Plan of Conservation and Development</u>: This agenda item will be discussed at next month's meeting. The Board will invite Mr. Van Hise, Chairman of the Planning Commission to next month's meeting.
- 4. <u>Emergency Services Stipend Discuss new ordinance</u>: First Selectman S. Dunn discussed the Emergency Services Stipend as well as the new ordinance.
- 5. Town Garage Tank Removal, Installation, and Canopy: A motion was made by Chairman R. Gianazza, seconded by Secretary S. Hathorn, to subtract \$75,000 out of line item in the capital budget for the roof and add to the tank. Chairman R. Gianazza rescinded the motion.

A motion was made by M. Mulvaney, seconded by Vice Chairman J. Rossi, to deduct from the line of the capital expense of the roof in the amount of 47,000, and add that to the line item to replace fuel tanks at the Town garage. M. Mulvaney withdrew the motion.

A motion was made by M. Zerbe, seconded by M. Mulvaney, to transfer \$47,000 from the Capital Budget line item for the roof at the Town Hall building to be applied toward the additional expenses associated with removal and installation of new fuel tanks at the maintenance facility; contingent upon unconditional approval by the Town Attorney. Motion ties 3-3. First Selectman S. Dunn broke the tie with a yes vote.
