Minutes of the Historic District Commission Thursday, May 3, 2012 Brookfield Town Hall

Pre-Hearing: Brookfield Library New Signage

Anita Barney presented the proposed plans for a sign with a reader board to announce programs held at the Library. The sign will be a white board with black letters placed in the vicinity of the cement steps in front of the Library or near the street light. The sign will be sized within the zoning regulations.

The Historic District Commission has no objection with the erection of the new sign. The Commission requested that the Library return an application for a Certificate of Appropriateness with an actual drawing of the sign and plans for the type of lights for illumination. It was suggested that low landscaping below the sign be used to prevent damage to the sign by lawn maintenance and also to hide ground lights if they choose to illuminate the sign. The color and type of lights need approval by the HDC. The recommended color would be similar to an incandescent bulb.

Betsey McIlvaine also mentioned that the tree in front of the Library cottage was cut down, and the debris in the road and at the back of the barn has been removed. The Library Board will keep in contact with the Town in an effort to continue maintaining the cottage and barn property. This was in reference to a letter that was sent January 24, 2012 to the Library Board of Trustees regarding the deterioration of the property to the west of the Library building.
