Application 2012-04: Jeff & Barbara Roeder, 4 Long Meadow Hill Road for the addition of a stove pipe chimney on the residence.

J. Roeder described the installation of an 8-inch stovepipe for a wood stove exiting porch roof approximately 16-inches from exterior wall on addition in rear of the house. The stovepipe would be approximately 2-feet laterally displaced and behind the edge of original structure. The pipe will be allowed to weather or be painted black. The lower portion would match the house color.

The stovepipe would not be visible from the front of the house, and visibility is limited from the rear.

The Commission members did not have any negative comments on the proposed stovepipe. It was suggested to leave the stovepipe the natural gray color of the metal.
