- 3. Huckleberry Hill Roof Project Update: Chairman Checco reported that the project is going well. The material that is being used is PVC and the contractor is New Britain Roofing. The total cost of the project is \$837,400.00. There was a special Town meeting in April, 2012 to appropriate the expenditure for the roof replacement. The MBC was asked by the BOE to bring in an architect to recommend a roofing consultant. The project was approved by SFU. It was bid out and bids were awarded in about 1 ½ months. The project includes brick repointing, washing down the building, all of the gutters, all of the fascia, the roofing, drainage, the front canapé and the asbestos abatement. The bulk of the roof is complete and the fascia work will be started next week. There is a 20 year warranty for the roof. The Town will receive 32% reimbursement from the State due to the total removal of the roof and total replacement.

The motion was seconded by Josh Flowers and passed unanimously, 6-0.

A motion was made by Anthony Licursi to approve Application #1 from New Britain Roofing for work through 7/31/12 in the amount of \$227,325.50. The motion was seconded by George Brown, Jr. and passed unanimously, 6-0.
