**CALL TO ORDER:** First Selectman Stephen C. Dunn called the meeting to order at 5:15 p.m.

**SOUTHERN FEDERAL ROAD WATERLINE PHASE I-III AND DEL MAR DRIVE:** A Public Hearing was held on October 5, 2016 for the purpose of receiving public comment and answer questions relative to the waterline assessments pursuant to Ordinance 215. At conclusion of discussion, **Steve Dunn made motion that the Selectmen approve the final Southern Federal Road Waterline Phase I-III and Del Mar Drive Waterline Assessments [attached] as presented at the October 5, 2016 Public Hearing and Board of Selectmen Meeting. Motion seconded by Martin Flynn, and carried by majority.**

**2016-2020 TRANSPORTATION ALTERNATIVES PROGRAM (TAP) GRANT:** The Selectmen tabled this item at their October 5 regular meeting for further discussion of the range and match to request for this grant. At conclusion of discussion, **Steve Dunn made motion that the Selectmen forward a request to the Board of Finance for the Town to submit a 50/50 match in an amount up to \$950,000 for the TAP Project Proposal Summary, contingent upon Board of Finance approval. Motion seconded by Martin Flynn, and carried by majority.**

**ADJOURN:** Steve Dunn adjourned the meeting at 5:25 p.m., seconded by Martin Flynn. Motion carried by majority.
