1. Having been duly noticed, the meeting was called to order at 6:34 PM.

2. Public Comment: None

3. <u>Minutes</u>: Tom L. moved to approve the July 14th, 2011 minutes as written, Richard seconded and the motion passed.

- 5. Old Business:

A. New Town Website: Tom G. reported that the site is supposed to go live on 1 November. Tom G. sent the webmaster two years of minutes to upload, as well as a ToTF Mission Statement and links to key resources relating to the Trustees' work.

E. Cemetery Trust Interest Allocation: Tom L. will look for last audit. Failing that, Tom G. will contact State Charitable Trust Unit to receive. Once received, corrections as needed will be made by Rich N and submitted for discussion and approval to the Trustees.

C. 2012 Budget – Trustees discussed budget proposal for 2012 and resolved to request \$600, consisting of \$450 for salaries, \$50 for dues and subscriptions, and \$100 for training. Motion made by Tom L, seconded by Richard, passed unanimously.

D. Draft 2011 Annual Town Report – Presented by Tom G. Discussed and approved. Rich moved, Tom L. seconded, motion passed unanimously.

E. Response to Information Request from State Charitable Trust Unit: Tom G. reported that the SCT Unit requested copies of Authorization Authority for Scholastic Trust Funds A and B. Tom G. researched and provided Warrant Articles form 1995 Town Meeting.

7. Other Business:

A. Unused Trust Accounts: Tom G. will research to determine if a Warrant Article is required to remove these empty accounts.

B. Asset Allocation: Trustees noted that portfolio performance is lagging inflation and net worth of Trusts is being eroded. Rich will set up meeting with Cutwater to discuss options, potentially at next Trustee meeting.
