The motion was seconded by Ms. Smith.

Cont. Correspondence:

12-03-03 – Correspondence from Casa Fernandes regarding connection of their restaurant, Casa Fernandes, located at 299 Spring Lake Road, Glendale – Mrs. Fernandes stated that she plans on installing the grease trap for the restaurant first and then she will finish the connection to the sanitary sewer system in the Spring.

Voted – Ms. Smith made a motion to continue this item until next month and that a plan be submitted for the connection before the next meeting. The motion was seconded by Mr. Peterson.

Correspondence:

12-05-06 – Correspondence from Kevin Cleary regarding a proposal for a canoe launch site along Clear River in the vicinity of the Waste Water Plant and the Animal Shelter

Voted – Mr. Peterson made a motion to have Mr. Kane write a letter stating the Commission accepts the proposal with the possibility of a land acquisition in the future. The motion was seconded by Ms. Smith.

12-05-07 – Correspondence from Robert Sweeney requesting to be placed on the Commission's agenda regarding his connection – Mr. Sweeney stated that he thinks he will have the money to do the connection this Spring.

Voted – Mr. Peterson made a motion that Mr. Sweeney needs to submit application prior to the next Commission meeting with a letter stating that his property will be connected to the sanitary sewer system by the end of May, 2012. The motion was seconded by Ms. Smith.

Memo from John E. Martin, Superintendent, regarding sewer manhole documentations as requested by Commission – Mr. Martin stated that the manhole in question on Steere Farm Road is not a sewer manhole cover. Mr. Baker stated that he will have a crew investigate that manhole. Mr. Kane noted that Reservoir Road had been resurfaced since sewer had been put in. Mr. Baker stated that he would come back to the Commission with a Construction & Maintenance agreement. Mr. Martin noted that the Commission is willing to provide the manhole frames and covers when RI DOT does the repair work should they need them.

Voted – Mr. Peterson made a motion to place item on next month agenda for an update. The motion was seconded by Ms. Smith.

12-05-08 – Correspondence from Matthew Stamp update on connecting his two (2) properties to the sanitary sewer system – Mrs. Franklin reported that P&R Construction is supposed to drop off the sewer application and sketch today and that the checks from Mr. Stamp are in the mail.

Letter to Mr. Haberek, P.E., DEM, requesting a ninety(90) day time extension on behalf of the Commission to properly review DEM Draft Permit forwarded to Commission on October 17, 2011

Discussion of draft RIPDES permit – There was much discussion on the draft RIPDES permit. Mr. Geremia noted that the Commission asked for a ninety (90) day extension and DEM gave them forty five(45) days. Mr. Geremia also noted that he will set up a meeting with himself, Mr. Martin, Mr. Wolfe, and representatives from DEM for sometime next week.

Voted – Mr. Peterson made a motion to continue this item at the next Commission meeting. The motion was seconded by Ms. Smith.

Engineer's Report

Status update of School Street/Eagle Peak Stations – Mr. Geremia reported that there are still problems with the pump at Eagle Peak and he is trying to schedule a meeting with the contractors and electricians to resolve this matter.
