- 1) That the question of approving minutes of the regular meeting of the Burrillville Rubbish and Recycling Committee held on August 23, 2010, and the question of dispensing with the reading of said minutes; be now taken up. Colleen Joubert motioned to approve minutes. It was seconded by Christine Mulligan and unanimously approved.
- 2) Introduction of Recycling Coordinator, Andrea Hall.

- 3) Consideration/action relative to application for Ocean State Power Community Foundation grant. Christine Mulligan suggested a shred event for residents.

Colleen Joubert suggested a grant for education (field trips to RI Resource Recovery Corp.). Andrea Hall will check with schools and let them know that we could try and get money for field trips to RIRRC. After some discussion, we agreed that it would be better to try and get a grant for the field trips. Christine Mulligan made a motion that we start work with the grant. It was seconded by Greg Mislick and unanimously approved.

- 4) Discussion/action relative to Committee attendance at Clean Water Action Meeting to be held Thursday, September 30, 2010 from 8:30-11:30. Andrea Hall will be attending.
- 5) Discussion/action relative to America Recycles Day, November 15, 2010. On a Monday. Some suggestions on how to recognize the day were opening up Whipple Ave facility on this day, we need to ask Jeff McCormick and/or a bargain buyer ad. Colleen Joubert suggested a ½ page bargain buyer ad with a dual purpose (No Bin No Barrel Campaign and America Recycles Day).

**Unfinished Business to be considered and acted on:**

- 6) Discussion/action relative to No Bin, No Barrel (NBNB) implementation- official NBNB ad for launching of program. Colleen Joubert will put together a full page ad for this purpose. Greg Mislick asked her to email it to him as well so we could have posters made of the ad to hang up in various areas of town.
- 7) Andrea Hall went over Kim Grant's plans for banners for the No Bin No Barrel Program. Colleen Joubert will design a 20' x 3' road banner (printed on both sides). Andrea also showed us what she had so far for packets for each home. There will be approximately 6,000 packets so it is a substantial amount even to split up between only a few people. Donald Fox mentioned to try mass bulk mailing or a Bargain Buyer insert. These options will be looked into. Also, maybe there are high school students who are in need of community service time who would be willing. This option will also be explored.
- 8) Discussion/action relative to Pay-as-you-Throw. Tabled
- 9) Adjournment. Meeting was adjourned at 8:34pm. It was motioned by Christine Mulligan, seconded by Allison Gelfuso and approved unanimously.
