Public Comment: None.

- 1) That the question of approving minutes of the regular meeting of the Burrillville Rubbish and Recycling Committee held on February 7, 2011 and the question of dispensing with the reading of said minutes; be now taken up. Greg Mislick motioned to approve minutes upon amending. Motion was seconded by Robyn Volpini and unanimously approved.

New Business to be considered and acted on:

- 2) Discussion/action relative to performance of Coastal Recycling. According to Andrea Hall, Coastal still has not gotten GPS installed into the trucks as agreed to. They also have not supplied the pamphlets that they said they would. They did drop off barrels to the DPW as promised for replacements for residents who complained of ones that were broken by them.
- 3) Review of Monthly statistics. February 2011 had a lower recycling rate than last year. Reasons for this could be the heavy snowfalls may have had some residents throwing out recycling (into trash) instead of keeping them separate. Also, due to the increased education of what can/can't be recycling, some residents may have been separating out everything with a recycling symbol instead of just 1's and 2's.
- 4) Discussion of Town Manager's communication regarding efforts to consolidate waste disposal contracts with neighboring communities. Christine Mulligan made a motion that we would be interested in working with the other communities (Smithfield, North Smithfield) on this effort. Greg Mislick seconded and it was unanimously approved.

Unfinished Business to be considered and acted on:

- 5) Discussion/action relative to EPA Grant. This expired on March 22. Christine Mulligan made a motion to table this permanently as we would not be able to make the deadline and it was seconded by Greg Mislick and unanimously approved.
- 6) Discussion/action relative to appointment of a new Committee member. The March Screening Sub-committee meeting was cancelled so there is no update.
- 7) Discussion of the feasibility of converting to in-house refuse/white goods pickup. David Place and Steve Rawson have been researching Gloucester. Start up cost for the town was a flat bed truck.
- 8) Discussion/action relative to a Pay-as-You-Throw program. David Place spoke with the recycling coordinator from Swansea. Within one year of implementing PAYT, they saw a 25% savings. This was implemented in 2001. They set up an enterprise fund (with the revenue from the program). They have approximately \$300,000 surplus currently. They put a dumpster ordinance in place for those who opt out of the program. The bill is sent out to residents separately. It is \$76/yr/household plus the cost of bags (80¢/15 gal bag and \$1.50/30 gal bag. An account needs to be set up for bags and stores would volunteer to sell them but town would need to work on account, collect money, and keep track of bags. There are companies that provide this service along with the purchasing of the bags.
- 9) Discussion/action relative to expending recycling funds to host a shredding/recycling event and sponsoring field trips to RIRRC. Andrea Hall was given approval but will need to notify Finance before any firm plans are made. Andrea Hall looked into Eco Depot (through RIRRC) but it needs to be scheduled one year in advance. For school field trips, Callahan School is interested, and maybe Levy, according to Andrea Hall.

There was a discussion of whether or not we need to have a school committee member attend all meetings.

Robyn Volpini made a motion that we do not need permanent involvement by a school committee member in the Rubbish and Recycling Committee. It was seconded by Colleen Joubert and all approved.

- 10) Discussion/action relative to community outreach:
 - a). Farmers' Market. Christine Mulligan will try to find out if there is a recycling theme planned this year and we could work at it and plan a shredding event.
 - b). Formation of a Youth Litter Patrol. Andrea Hall has an idea of working with the schools with a program called ABC (A Better Community).
- 11) Discussion/action relative to involving other entities in recycling effort
 - a). Small businesses- Greg Mislick pointed out that automation would be needed to handle large amounts of glass bottles due to weight of bins.

b). Levy Rink- they currently don't have anything. They could blue bins. Chris Lacey could provide us some information on the rink.

c). Spring Lake- will need to talk to Cheri Hall. They do currently have some recycling in place.

12) Adjournment. Meeting was adjourned at 8:29pm. It was motioned by Christine Mulligan, seconded by Greg Mislick and approved unanimously.

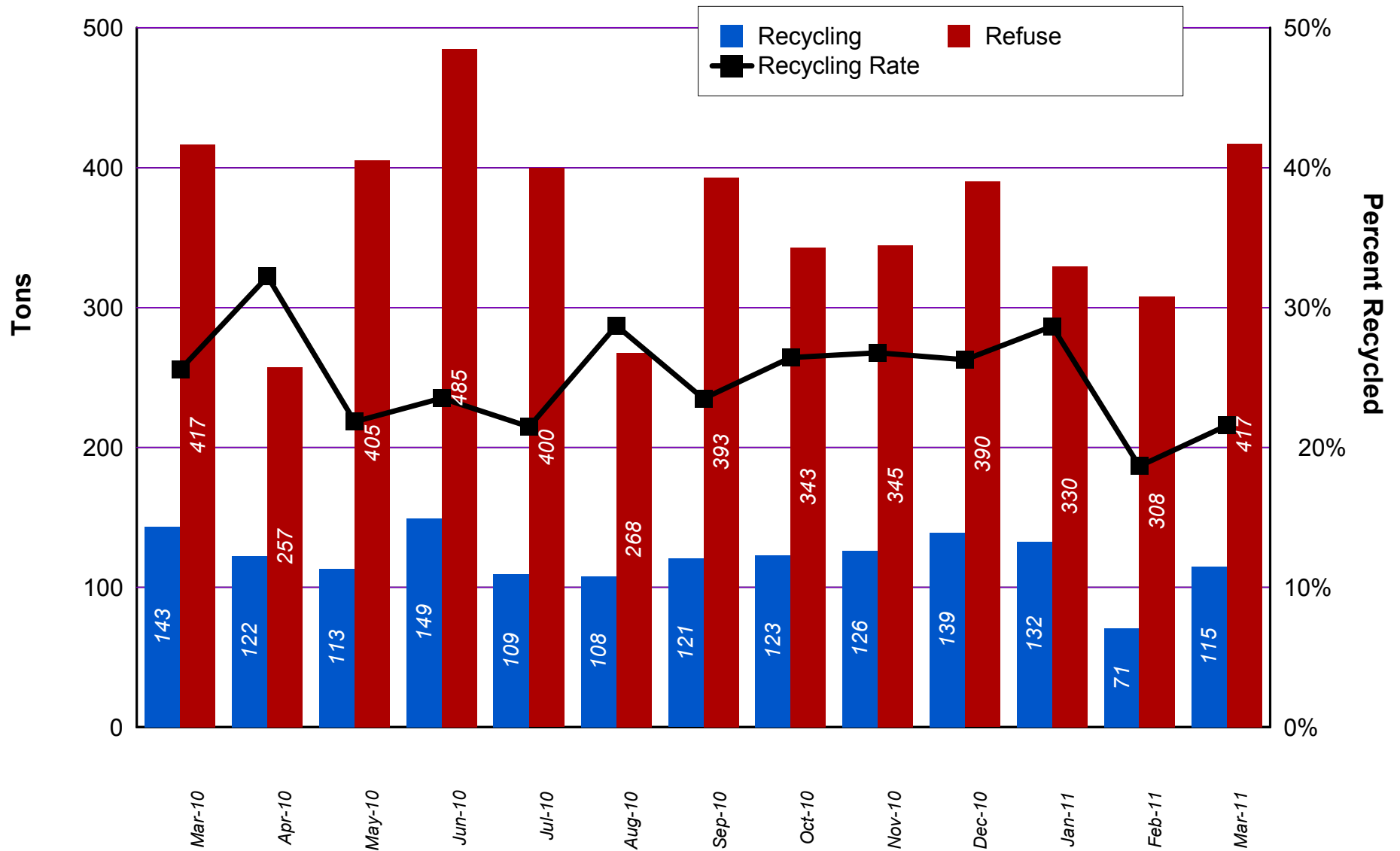

RELATING TO HEALTH AND SAFETY -- ENERGY

Introduced By: Representative Jon D. Brien

Date Introduced: February 09, 2011

Referred To: House Municipal Government

It is enacted by the General Assembly as follows:

1 SECTION 1. Section 23-19-11 of the General Laws in Chapter 23-19 entitled "Rhode
2 Island Resource Recovery Corporation" is hereby amended to read as follows:

3 **23-19-11. Planning requirements.** -- Planning responsibilities of the corporation shall
4 include, but not be limited to:

5 (1) The preparation of a statewide resource recovery system development plan which
6 will indicate the location, type, and size of solid waste management facilities, including without
7 limitation, transfer stations, waste processing facilities, and ultimate disposal facilities which may
8 be required to serve the future needs of the state and its municipalities through the development
9 of an integrated statewide resource recovery system for the effective management of solid waste;

10 (2) The plan shall be in conformity with the applicable provisions of the state guide plan;

11 (3) The plan will be subject to amendment;

12 (4) In developing the plan, the corporation will assure that:

13 (i) The orderly extension of future solid waste facilities and management systems are
14 provided for in a manner consistent with the needs and plans of the whole area, and in a manner
15 consistent with the state departments of health and environmental management rules and
16 regulations for locating and operating solid waste facilities;

17 (ii) All aspects of planning, zoning, population estimates, engineering, and economics
18 are taken into consideration to delineate with all practical precision those portions of the area
19 which may reasonably be expected to be served by a given time frame, as determined by the

1 corporation;

2 (iii) Appropriate time schedules are set for the phasing in of the required component
3 parts of the system.

4 (iv) Future solid waste disposal facilities shall be regional in size and emphasize the
5 geographic and political nature of the surrounding area.

6 (5) In the interim prior to the completion of the statewide plan, the corporation is
7 authorized to develop component facilities as may be required to carry out the purposes of this
8 chapter; provided, however, upon completion of the plan, all projects of the corporation
9 undertaken thereafter shall be in conformity with the plan; and

10 (6) The corporation shall cooperate with the department of environmental management
11 and other state and local agencies in the development of a comprehensive statewide solid waste
12 management plan, of which the corporation's statewide resource recovery system development
13 plan shall be a component part. Nothing in this chapter shall be interpreted as limiting the
14 authority of the department of environmental management to prepare a statewide, comprehensive,
15 solid waste management plan, including, but not limited to, any plan required by any federal law,
16 rules, or regulations to meet federal requirements that may be conditions precedent to receiving
17 federal assistance.

18 ~~(7) The plan shall not include incineration of solid waste.~~

19 ~~(8)~~(7) The plan shall limit the use of landfills to providing temporary backup or bypass
20 disposal capacity and residue disposals from waste processing facilities. The plan shall also seek
21 to minimize landfilling of any type of waste and phase out the use of landfills for waste disposal.

22 ~~(9)~~(8) The plan shall include composting of yard waste and other appropriate organic
23 wastes.

24 ~~(10)~~(9) The plan shall consider the financial feasibility of modifying, curtailing, or
25 supplanting the provisions of chapter 19.1 of this title in light of the requirements for waste
26 processing facilities.

27 ~~(11)~~(10) The plan shall primarily rely on a system of waste processing facilities.

28 ~~(12)~~(11) The plan shall provide that the corporation actively pursue research and develop
29 new uses for materials recovered from solid waste to maximize revenue from recycled materials.

30 SECTION 2. Section 39-26-5 of the General Laws in Chapter 39-26 entitled "Renewable
31 Energy Standard" is hereby amended to read as follows:

32 **39-26-5. Eligible renewable energy resources.** -- (a) For the purposes of the regulations
33 promulgated under this chapter, eligible renewable energy resources are generation units in the
34 NEPOOL control area using:

- 1 (1) Direct solar radiation;
- 2 (2) The wind;
- 3 (3) Movement or the latent heat of the ocean;
- 4 (4) The heat of the earth;
- 5 (5) Small hydro facilities;
- 6 (6) Biomass facilities using eligible biomass fuels and maintaining compliance with
- 7 current air permits; eligible biomass fuels may be co-fired with fossil fuels, provided that only the
- 8 renewable energy fraction of production from multi-fuel facilities shall be considered eligible;
- 9 (7) Fuel cells using the renewable resources referenced above in this section;
- 10 (8) ~~Waste-to-energy combustion of any sort or manner shall in no instance be considered~~
- 11 ~~eligible except for fuels identified in section 39-26-2(6).~~ Waste-to-energy technology at a facility
- 12 located in the city of Woonsocket approved by the Rhode Island resource recovery corporation,
- 13 subject to the permitting, regulatory, and monitoring authority of the department of health and the
- 14 department of environmental management granted pursuant to section 23-19-12 and any other
- 15 applicable section of the general laws and subject to licensing as required in the Energy Facility
- 16 Siting Act, and; provided further, that in no case shall any facility be permitted unless the
- 17 operation of such facility shall meet all applicable standards established by the United States
- 18 Environmental Protection Agency pursuant to sections 111 and 129 of the Clean Air Act, 42
- 19 U.S.C sections 7411, 7429.
- 20 (b) A generation unit located in an adjacent control area outside of the NEPOOL may
- 21 qualify as an eligible renewable energy resource, but the associated generation attributes shall be
- 22 applied to the renewable energy standard only to the extent that the energy produced by the
- 23 generation unit is actually delivered into NEPOOL for consumption by New England customers.
- 24 The delivery of such energy from the generation unit into NEPOOL must be generated by:
- 25 (1) A unit-specific bilateral contract for the sale and delivery of such energy into
- 26 NEPOOL; and
- 27 (2) Confirmation from ISO-New England that the renewable energy was actually settled
- 28 in the NEPOOL system; and
- 29 (3) Confirmation through the North American Reliability Council tagging system that
- 30 the import of the energy into NEPOOL actually occurred; or
- 31 (4) Any such other requirements as the commission deems appropriate.
- 32 (c) NE-GIS certificates associated with energy production from off-grid generation and
- 33 customer-sited generation facilities certified by the commission as eligible renewable energy
- 34 resources may also be used to demonstrate compliance, provided that the facilities are physically

1 located in Rhode Island.

2 SECTION 3. Section 42-98-3 of the General Laws in Chapter 42-98 entitled "Energy
3 Facility Siting Act" is hereby amended to read as follows:

4 **42-98-3. Definitions.** -- (a) "Agency" means any agency, council, board, or commission
5 of the state or political subdivision of the state.

6 (b) "Alteration" means a significant modification to a major energy facility, which, as
7 determined by the board, will result in a significant impact on the environment, or the public
8 health, safety, and welfare. Conversion from one type of fuel to another shall not be considered to
9 be an "alteration."

10 (c) "Board" for purposes of this chapter refers to the siting board.

11 (d) "Major energy facility" means facilities for the extraction, production, conversion,
12 and processing of coal; facilities for the generation of electricity designed or capable of operating
13 at a gross capacity of forty (40) megawatts or more; transmission lines of sixty-nine (69) Kv or
14 over; facilities for the conversion, gasification, treatment, transfer, or storage of liquified natural
15 and liquified petroleum gases; facilities for the processing, enrichment, storage, or disposal of
16 nuclear fuels or nuclear byproducts; facilities for the refining of oil, gas, or other petroleum
17 products; facilities of ten (10) megawatts or greater capacity for the generation of electricity by
18 water power, and facilities associated with the transfer of oil, gas, and coal via pipeline; any
19 energy facility project of the Rhode Island economic development corporation; the board may
20 promulgate regulations to further define "major energy facility" to the extent further definition is
21 required to carry out the purpose of this chapter, provided that any waste to energy facility shall
22 ~~not~~ be deemed a major energy facility for the purposes of this chapter.

23 (e) "Clean coal technology" means one of the technologies developed in the clean coal
24 technology program of the United States Department of Energy, and shown to produce emissions
25 levels substantially equal to those of natural gas fired power plants.

26 SECTION 4. This act shall take effect upon passage.
