## Learning Center Sub-Committee

October 25, 2016

Guests included Steve Knox and members of the Commissioner's Farm Advisory committee, Representative Ticehurst, Commissioners Sorensen and Babson, and staff of NHTI Community College.

Rep. Cordelli opened the meeting at approximately 7 pm at The Community School in South Tamworth.

Ms. Lianne Prentice, Director. welcomed us to the school. She explained that the school is a private school for grades 6 through 12 with a college prep focus. It is on the former Perkins Farm and has over 300 acres and a certified organic farm. They view the property as an educational facility and attempt to look at the needs of the region.

The school operates with just on full time staff person (Ms. Prentice) approximately 20 part-time staff.

Several students made an informative presentation on projects they were working on including rotational grazing for soil regeneration, community composting, and researching bioshelters.

We next had a presentation from Professor Tracey Lesser of NHTI in Concord. She explained their new Sustainable Agriculture certificate program and that it includes accounting, business plan and loan application aspects. They also run a non-profit farm on-campus for refugees who get a plot on which to grow crops.

Professor Lesser introduced Trish Dionne, their Director of Online Learning. She discussed the online courses that are part of the certificate program – accounting and marketing. She also mentioned the estart and running start programs that would allow high school students to gain college credits. The possibilities for The Community School were discussed as well as the possibility for online courses at a future Carroll County Agricultural Learning Center. Also discussed was the possible partnership of Carroll County with NHTI and a tailored certificate program to the challenges in our area.

Ms Prentice wrapped up the meeting with further information about the challenges of a small private school including publicity and marketing.

The meeting as adjourned at approximately 8:15 pm.
