#### **ANNOUNCEMENTS**

The Town offices will be closed February 18th for Presidents Day.

A Public Hearing will be scheduled for February 25<sup>th</sup> at 7:15 pm regarding creation of a Local Law for written prior notice of defect of Town property.

#### **COMMUNICATIONS**

The Board received a letter of complaint from a resident on Vines Road about the number of cars parked in the road for the AIM Services house at 9 Vines Road. Supervisor Grattidge said that he also received a complaint by telephone from a resident on Crawford Drive, saying the cars parked in the road made the road difficult to travel on during a recent snowstorm. Councilman Grasso said that he called Christopher Lyons, Executive Director for AIM Services and notified him of the complaint. The Councilman said that he went back to the minutes of the original presentation by AIM Services to the Town, and he brought up some of the statements that were made at the time regarding the number of cars that were expected to be on site at any point in time. That is being significantly exceeded. Councilman Grasso brought those facts to Mr. Lyon's attention and he said that he would address the situation immediately and get back to the Councilman. He has not gotten back to him yet. The Councilman will follow up in a few days if he does not hear back. Supervisor Grattidge said that the Charlton Police has stopped there a few times and asked them to get the cars off the road for plowing.

#### **DEPARTMENT, COMMITTEE & COUNCILMAN REPORTS**

Councilman Robbins said that he has heard comments from residents saying that the Highway Department has done an excellent job with the roads during the recent snow and ice storms. He has also gotten complaints about potholes, especially on Lake Hill/Stage Road. He wanted to remind residents that Saratoga County is responsible for County Roads and that the County needs to be contacted for those potholes.

Highway – Superintendent Heritage gave the report for the month of January:

- 2. Finished picking up Christmas trees
- 3. Continue cutting brush on Rocky Ridge
- 4. Truck # 12 installed a new radiator
- 5. Took core samples of Jenkins road
- 6. Plowing roads
- 7. Sand/salting roads
- 8. Monthly safety meetings
- 9. Cleaning off trucks
- 10. I attended MS4 meeting
- 11. Painted truck # 12 dump box
- 12. Went to look over the new truck
- 13. Mixing up a pile of sand and salt
- 14. Greasing of the trucks and loader
- 15. We have started our defensive driving program
- 16. Had trucks 1& 26 inspected
- 17. (2) 811 dig locations

Supervisor Grattidge said that the Highway Superintendent has asked for authorization tonight for 2 items; a 2006 bucket truck and a 2003 Ford F-350. The authorization will be done later in the meeting.

Historian - Marv Livingston read excerpts from a 1992 reunion at Harmony School. Mr. Livingston said that recently there was an article in the newspaper telling that the Ambulance Corp. in Fulton had to shut-down due to lack of funding. He thanked the Town Board for having the foresight to allow the creation of an Ambulance District in Charlton.

Councilman Robbins said that he attended the annual County Planning Conference recently and he felt it was very well done. He found the presentation done on Farmland Protection very interesting and well done.

Town of Ballston Library - Colleen Smith gave the following report:

The Friends of the Library are looking for volunteers to help with the upcoming Library Mini-Golf event on Friday and Saturday, February 22 and 23. Volunteers are needed to welcome golfers, collect money, distribute score cards and golf clubs, oversee the course, sell refreshments, and take down the course on Saturday afternoon. They also need volunteers to help set up the course on Thursday, February 21 and donate baked (including store bought) goods for the bake sale. To volunteer for a two to three hour shift, or donate baked goods, register on the library's calendar, call the library at (518) 399-8174 (ext. 2) or sign up in person at the Circulation Desk. The library will be closing its indoor book drop effective February 19<sup>th</sup>. All materials can be dropped in the outdoor book drop located at the rear of the library building. Registration is now open for spring programs. Sign up online, or by calling or visiting the library. There will be a mobile planetarium on February 16<sup>th</sup>.

Zoning – For the month of January, there was 3 Building Permits issued, 2 permits closed, 3 searches completed, \$394.90 in fees collected, 8 CC/CO's were issued, permit value was \$1,293,125.00. For 2018, there were: 99 permits issued (which included 32 for permanent structures, 14 for septic and 11 for solar), \$20,400 in fees were collected and the permit value was \$6,396,116.00.

Dog Control – In January, there were 3 calls received, 7 expired licenses followed up on, and 5 Court appearance tickets issued.

Constables – In January, there were 36 patrols, 21 complaints received,17 911 calls, 10 accidents & 2 EMT/Fire calls responded to. 3,517 miles were traveled, and 66 tickets were issued (37 issued on Route 67).

Councilwoman Heritage said that she and Councilman Ranaletto did the annual audit of the Town Clerk's financial records and they feel that the Town Clerk is doing an excellent job.

Party in the Park – There will be a planning meeting at the Town Hall on February 26<sup>th</sup> at 7pm and anyone interested in participating or volunteering is welcome.

Planning Board – Councilman Grasso said that the Planning Board has no cases to hear this month, so there is no February meeting planned. He attended annual training conference held by the County Planning Department. He attended a course on Traffic Mitigation Strategies and one regarding SEQR. They also had a course on Maintaining Civility at Board Meetings. 580 people attended the conference and he highly recommends it.

In 2018, the Planning Board worked on Subdivision Application Review Guide which is given to applicants to guide them through the subdivision process and what is expected. The Planning Board submitted the recommended edits to Councilman Grasso and he is reviewing them and will work with the Town Attorney to get them ready for decision by the Planning Board and get them rolled out in the next few months.

Councilman Grasso said that he and Councilman Robbins completed the Town Board audits of the Bookkeeper, Building & Zoning and the Water Department. All of the accounts were in good order and with good record keeping. He expressed appreciation to the staff in those departments that help keep the records straight.

Saratoga Plan has notified that Town that that there are 2 property owners in Town that are applying for a grant that would cover the cost of appraisal of development rights, which would be the first step in helping those landowners to preserve the farmland through the conservation easement process. There have been 3 farmers in the past few years that have completed conservation of their farmland.

Cell Advisory Committee - Councilman Grasso said that he has received 12 responses to the notice looking for volunteers for the Cell Service Advisory Committee. 11 are Town residents, and 1 is not. We are looking to keep it just Town residents and are accepting applicants until February 15th. The Councilman will be calling each individual to discuss their level of interest and then make recommendations to the Town Board. The Board has previously talked about having 3 to 7 residents on the Committee. They have not decided how they will handle the large number of responses yet. One thing that a couple of residents previously mentioned was the rural broadband issue. The Councilman had thought that this was an issue that should be handled totally separately as it has its own issues and will require guite a bit of work. With so many respondents there may

be enough to handle both issues, cell phone and broadband. Or possibly break the group into 2 groups to handle the issues separately. He asked the Board to let him know in the next week if they have feedback on that idea.

Supervisor Grattidge confirmed that the old police car has been sold.

Supervisor Grattidge said that the Board is working with the HR Consultant to make updates to the Employee Handbook, which was last done in 2006.

Supervisor Grattidge and Councilman Robbins have begun putting together the criteria for the Ambulance Advisory Committee. They are still waiting for financial reports from one of the Ambulance companies.

RESOLUTION CALLING ON GOVERNOR CUOMO AND THE STATE LEGISLATURE TO CONTINUE AID AND INCENTIVES TO MUNICIPALITIES (AIM) PAYMENTS IN THE 2019-20 FISCAL YEAR STATE BUDGET

MOVED BY: Councilman Ranaletto

SECOND BY: Councilman Robbins

**WHEREAS,** Governor Andrew Cuomo released his Fiscal Year 2019-20 Executive Budget on January 15th; and

**WHEREAS,** the fiscal year 2019-20 Executive Budget is a proposed \$176 Billion spending plan; and

**WHEREAS**, the Executive Budget contains language to make permanent the cap on real property tax levy increases of two percent due to sunset in the year 2020; and

WHEREAS, New York State towns, villages and cities scheduled to receive Aid and Incentives to Municipalities (AIM) payments that are less than two percent of their local fiscal year expenditures, as reported to the State Comptroller, will be removed from the program resulting in the complete elimination of unrestricted state aid through AIM for most towns and villages; and

WHEREAS, such an elimination of AIM would hurt local governments and property taxpayers across the State, threatening core services, making compliance with the tax cap more difficult, and leaving upstate New York in a worsened fiscal position, leading to property tax increases or service reductions across towns and villages throughout the State; and

**WHEREAS,** if the Executive proposal is enacted, more than \$60 million in funding to towns, villages and cities in New York will be eliminated; and

**WHEREAS,** more than 1300 villages, towns and cities will be impacted, including the Town of Charlton, yet the Governor's proposal keeps most AIM to cities intact, essentially shifting a greater fiscal burden onto the town and village taxpayers; and

**WHEREAS,** the Town of Charlton would stand to lose \$32,695.00 in state AIM payments; and

WHEREAS, the proposed AIM payment cut to Charlton could result in a significant tax increase; and

**WHEREAS,** aid to localities for local roads and bridges under the state's Consolidated Local Street & Highway Improvement Program (CHIP) was maintained at 2018-19 levels in the Executive Budget;

**NOW, THEREFORE, BE IT RESOLVED,** that the Charlton Town Board respectfully calls on Governor Cuomo to rescind his proposal to eliminate AIM funding, restore AIM payments to the 1300 villages, towns and cities negatively impacted in his 30-Day Amendments to the Executive Budget, and requests state legislative leaders negotiate to make AIM payments permanent to the state's local governments with added upward adjustments to account for inflation on a yearly basis; and therefore, be it further

**RESOLVED**, that the Town Clerk is hereby directed to send certified copies of this Resolution to Governor Andrew Cuomo, New York State Senator James N. Tedisco, New York State Assemblyperson Mary Beth Walsh and New York State Division of the Budget Director, Robert Mujica.
