The Town Board will have a Workshop on May 28th at 6:15pm and meet with the Government Relations representatives from Charter Communications.

Verizon representatives plan to attend the May 28th Town Board meeting to give an update on their intentions for a cell tower in Charlton. They will be scheduled to speak at the beginning of the meeting.

The Historical Society will hold a Memorial Day Service at the Gideon Hawley Park gazebo on May 27th.

Grievance Day is May 28th and the hours are 2-4 pm and 6-8 pm.

The Charlton Ambulance Advisory Committee will have a workshop with the Ballston Lake EMS Board of Directors at their office on June 4th at 6:30 pm. Some of the Charlton Town Board members plan to attend.

Highway - Report given by Marshall Heritage:

- 14. Removed the four ton signs from the town roads
- 15. Got all the mowing equipment serviced

- 17. We had an employee retire after 30 plus years

The Highway Superintendent said that they plan to pave sections of Jenkins Road and Acorn Drive this Wednesday and Thursday. He also said that he is looking into purchasing a tamper, and will have information for the Town Board at the next meeting if he chooses to purchase one.

Councilman Grasso extended appreciation to Lee Bramer who recently retired from the Highway Department after 30 plus years of service.

Parks – David Pohl said that the parks are too wet for the Committee to do their annual walk through. They plan to replace basketball nets this year.

Historian – Marv Livingston said that there were 21 attendees for the annual flag marking of veteran graves in the Charlton cemeteries. He thanked Pat Motel and Larry Leone, owners of Gadsden and Culpepper for their donation again this year of the 28 dozen cemetery flags. Mr. Livingston shared some historical information regarding previous wars.

Councilman Robbins said that there is a need for people/groups to march in the Founders Day parade on June 2nd. The Saratoga County Veterans float will be in the parade and any veterans that wish to ride the float can report for the lineup.

Councilman Robbins said that he recently attended the Association of Towns sponsored Finance School done by the State Comptroller's office. He found the information to be very informative and said it will be helpful especially at budget time and if the Town wanted to start any capital reserve funds.

BHBL Community Library – Colleen Smith gave the following report:

- 1. The library's 2018 Annual Report to the Public is now available on the library's website, in print at the library or at the Charlton Town Hall.
- 2. Registration for Summer Reading Volunteers starts on May 20 at 4:00 pm. Students must register for a mandatory training session on June 6 at 4:00 pm or June 10 at 6:30 pm. The program is open to students entering grades 6-12.
- 3. Author Louise Miller will visit the library on Monday May 20 at 6:30 pm. Ms. Miller is the author of The City Baker's Guide to Country Living and The Late Bloomers' Club. She is a pastry chef who lives, writes, and bakes in Boston, MA. This event, including pastry-themed refreshments, is supported by the Friends of the Library. Registration online or at the library is requested.
- 4. The library's book sale and spring fling basket raffles were record setting fundraisers this spring. Thank you to the Friends of the Library, library staff, and volunteers who assisted with these wonderful fundraisers.
- 5. The library will be closed on Monday, May 27 for Memorial Day.

Zoning – For the month of April, there were 5 Building Permits and 1 C/O issued, and \$375.00 in fees collected. They have completed a 4 year trend report which Councilman Ranaletto will review and then share with the Board.

Constables – In April there were 38 patrols, 11 complaints received, 6 911 calls, 1 accident & 3 EMT/Fire calls responded to. 3,900 miles were traveled, and 52 tickets were issued (20 issued on Route 67).

Dog Control – In April, there were 9 calls received; 1 pertaining to other animals, 4 expired licenses followed up on, and 6 dogs returned to owners.

Party in the Park – The committee is gearing up for the event. The bands this year are the Melody Makers and the Rogues.

Planning Board – Councilman Grasso said that there was no April meeting, but the Board will meet on May 20th and do a courtesy review of the application for a new fire station by the Charlton Fire District #1, and also work on a 2 lot subdivision.

Cell Advisory Committee – Bert Wilson said that the committee has been meeting for about 3 months. They are looking at ways to enhance cell service and underserved broadband areas. The committee is preparing feedback for the Town Board. Verizon did a balloon test on May 9th and flew the balloons at 120,140 and 160 feet. He said that Senator Tonko recently signed legislation regarding rural broadband. The committee will look into that and see if that is something that they can work on. Councilman Grasso said that the proposed cell tower at 764 Charlton Road would be 120 feet. The Town Engineer also took pictures of the balloon test for added accuracy.

Councilman Grasso said that he attended the Association of Towns sponsored Finance School done by the State Comptroller's office. He said it was excellent, and feels that all Board members should attend the training as it highlights their fiscal responsibilities.
