# **SUPERVISORS REPORT**

Supervisor Grattidge said that the NYBridges grant application has been filed, and the Town has been notified that the results will be known sometime after late summer.

Supervisor Grattidge said that the annual MS4 report is done. The Town Clerk confirmed that the report has been put on the website and is available on the Town Clerk's counter.

The Supervisor has spoken with County Waste about picking up bulk items from residents at a reduced fee to residents in October. County Waste has agreed to waive the travel fee and will lower the prices per item picked up. More information will be made available in the fall.

Supervisor Grattidge said that Councilman Ranaletto contacted some of the trucking companies that use Charlton Road and asked them to have their drivers use another route. It appears to have been successful.

Supervisor Grattidge said that Global Foundries had a meet-and-greet meeting with the Saratoga County Supervisors and it was very impressive and informative. The company has invested 15 billion dollars locally and has 3,300 full time employees. There is a possibility that they will have further expansion.

There was an incident earlier today where a Charlton resident made social media posts to do harm in the Burnt Hills Schools. The Sheriff's Department has made an arrest and a search of the man's home found no guns.

Superintendent Heritage reminded people to have their brush curbside by April 22<sup>nd</sup>. He also thanked Dave Wood for gifting the Highway Crew with tickets to the West Charlton Fire Department's pancake breakfast.

Historian – Marv Livingston introduced Daniel Woloszyn, who is planning to restore the Swart Cemetery on DeGraff Road as his Eagle Scout project.

Town of Ballston Library - Colleen Smith reported that the Library will host Active Shooter Training on April 14<sup>th</sup>, and an Active Shooter drill on April 21<sup>st</sup>. The Spring Fling raffle begins April 10<sup>th</sup>, and the K-8 Student Art Show is April 14<sup>th</sup>. They will be doing their annual egg incubation program this month as well.

Galway Library - Arlene Rhodes, President of the Library Board, said that the library serves residents in the Galway School District. She said that bids for the new library building went out today, will be opened May 7<sup>th</sup> and they would like to start construction in May as well. The New library will be on East Street in the village. The library offers programs including, writers group, reading discussion group, open art session, tea at 3, and mahjong.

Galway Food Pantry – thanked the Town Board for continued financial support. The pantry gave out 87 spring food baskets this year.

Constables – In March, there were 26 patrols, 8 complaints, 4 911 calls, 2 accidents & 2 EMT calls responded to. 1,685 miles were traveled, and 55 tickets were issued (19 issued on Route 67). Constable Tom Parks said that there was a multiple injury accident on Route 67 and West Line Road in March.

Dog Control – In March, there were 7 calls, 3 expired licenses followed up on, 2 dogs were seized and returned to owners, 1 dog bite case reported, and 1 court appearance ticket issued.

Planning Board – Councilman Grasso said that the Board reviewed the site plan for the Capital Care expansion and a lot line adjustment on the Hodgkins property.

ZBA – the Board will be meeting this month to discuss a proposed ground mounted solar system on Eastern Avenue, and will hold a Public Hearing regarding an area variance on Vines Road.

Councilman Grasso said that the NYS mandatory Workplace Violence Training has been done for this year and 26 employees attended. A meeting regarding the deferred compensation plan was also held.

Seniors – Torben Aabo said that the painting at the Community Center is done and it looks beautiful. He said that there are exercise classes 4 times a week, movie day, book club, trips, etc.

Cell Antenna - The Town has not heard back from Verizon in the past few weeks.

Spectrum Cable – Supervisor Grattidge said that he received a call from their Construction Manager saying that they are extending cable on upper North Line Road and upper Cook Road. He said that the Board is hoping to meet with the cable company to talk about any possible extensions that they are working on and the franchise agreement that they have been working on.

WHEREAS, the Town Board did on August 12, 2008, approve an exceptional use permit (EUP) to MPH Properties, LLC/Charlton Family Medicine – Capital Care (hereafter MPH) site plan for 312 Stage Road, and

WHEREAS, the Town Board received the initial application dated February 5, 2018 from MPH to amend the original EUP granted to MPH on August 12, 2008, and

WHEREAS, on February 12, 2018, MPH made a formal presentation to the Town Board, after which the Town Board accepted jurisdiction for consideration of this application, and

WHEREAS, on February 15, 2018, the Town Board received an opinion letter from Town Engineer Michael S. McNamara regarding the MPH application, and

WHEREAS, on February 19, 2018, MPH made an informal site plan presentation to the Town Planning Board, and

WHEREAS, on February 23, 2018, the Town Board received written comments from the Town Planning Board on its informal site plan review of February 19, 2018, and

WHEREAS, also on February 23, 2018, MPH submitted an amended site plan to the Town Board with minor changes based on the applicant's information meeting with the Town Planning Board, and

WHEREAS, on February 26, 2018, the Town Board referred the MPH application to the Town Planning Board, Town Environmental Conservation Commission (ECC) and the Saratoga County Planning Board for their review and comments, and

WHEREAS, also on February 26, 2018, the Town Board approved a resolution acknowledging receipt of the MPH EUP, acceptance by the Town Board of primary jurisdiction, acceptance of lead agency designation for all required environmental reviews and the scheduling of a public hearing on the application for March 26, 2018, and

WHEREAS, on March 9, 2018, the Town Board received a comprehensive response in writing from Lansing Engineers, P.C. responding to the February 15, 2018 letter issued by Town Engineer McNamara and regarding the subject application, and

WHEREAS, on March 19, 2018, MPH made a formal presentation regarding the requested site plan changes to the Town Planning Board, and

WHEREAS, the Town Board received an e-mail from the Town Planning Board on March 20, 2018 submitting its opinion regarding the current application by MPH, and

WHEREAS, on March 23, 2018, the Town Board prepared and submitted the required Short Form Environmental Assessment, together with Part 1 and Part 2 of such document, and

WHEREAS, pursuant to Part 617 of the Implementing Regulations pertaining to Article 8 of the State Environmental Quality Review Act (SEQRA), it has been determined by the Town Board of the Town of Charlton that this action constitutes an unlisted action as defined under such regulations and the adoption of such resolution would not have a significant effect on the environment and could be processed by the Town Board without regard to SEQRA, and

WHEREAS, on March 26, 2018, the Town Board conducted a public hearing on the proposed amendment to the MPH EUP, following which the Town Board determined that the EUP application should be classified as an Unlisted Action and further determined and did make a negative declaration relative to the environmental significance of the proposed land use subject of the EUP application, and

WHEREAS, on March 26, 2018, the Town Board requested that the applicant make some minor additions and/or alterations to some landscaping trees either currently or to be located on the subject premises, which site plan has been subsequently changed to reflect such modification showing relocation of some landscaping trees in order to screen the additional parking requested by the applicant and as shown on the attached updated site plan reflecting the current site status as of April 3, 2018.

NOW THEREFORE BE IT RESOLVED, that the Town Board hereby grants the application of MPH Properties for an amendment to the EUP granted by the Town Board on August 12, 2008 and as described or shown on the attached site plan.
