ANNOUNCEMENTS

There will be a Public Hearing on the 2018 Preliminary Budget at the Charlton Town Hall on October 23rd at 7:00 p.m.

The Fall Brush pick-up is scheduled for the week of October 23 -27. All brush should be curbside by October 22nd.

DISCUSSION

Supervisor Grattidge said that he received an email today from a Senior Citizen concerned with parking and safety for the Meet the Candidates night scheduled to be at the Community Center on October 18th. She asked if the event could be at the Town Hall. Supervisor Grattidge said that this event is put on by the Charlton Seniors. He asked the Board if they had any objection to allowing the Seniors to host the event at the Town Hall if they chose to do so. The Board had no objection.

DEPARTMENT & COMMITTEE REPORTS

Dog Control – In September, there were 8 complaint calls received, 3 expired licenses were followed up on, 1 complaint regarding other animals, 1 dog bite case reported.

Constables – In September, there were 24 patrols, 25 complaints, 17 911 calls and 4 accidents, 4 EMT/fire & 3 EID call responded to and 2,331 miles driven. 51 tickets were issued of which 29 were issued on Route 67.

Parks Committee – Dave Pohl reported that the Committee is getting quotes for a pathway to the gazebo from the parking area. They are planning to put in a pathway of concrete pavers in 2018. They are also looking for boy scouts that would like to replace the small culvert and footbridge in Elmer Smith Park as an Eagle Scout project. They are planning to stain the warming hut this fall. They would like to coordinate with the Highway Department to obtain the stain from Burnt Hills Hardware.

Highway – After the Department finishes roadwork, they will be helping neighboring Towns with handling materials as part of their inner-municipality agreement. They are waiting on the final paving bill to submit paperwork for CHIPS reimbursement.

Zoning – For the month of August, 18 building permits and 7 CO/CCs were issued. \$5,503.96 was collected in fees, and the total permit value was \$172,542.00.

Planning Board – The Board is looking at a 2 lot subdivision on Route 147 and a Public Hearing regarding it will be held next Monday night.

Food Pantry – The Greater Galway Community Service Association that runs the Pantry sent a report. The Pantry is available to Charlton residents that meet the income qualifications.

ECC – Marv Schorr said that the Committee met in September and reviewed the subdivision application for the property on Route 147. They will be sending a recommendation letter to the Planning Board.

Charlton Seniors – Marv Schorr said that the Senior will be hosting a Meet the Candidates night on October 18.

Historian – Marv Livingston said he has a plaque as a show of appreciation to Larry Leone and Gadsden and Culpepper for donating the flags for Veterans graves for the past few years. He recently found a book by Frank Lafforthun called Charlton Heritage. It contains lots of information and research on early settlers and will be helpful for assisting people with genealogy searches.

COUNCILMAN REPORTS

Councilman Grasso said that there has been no update on the Verizon cell antenna application. The new Stewarts Shop has opened and the ribbon cutting ceremony was held on Friday October 6th. He has received lots of positive feedback about the new location. Many people are pleased with the way that the lot is laid out and feel that it is a dramatic improvement over the old location. The welcome to Charlton sign has been installed. The gas pumps and canopy have been removed from the old location.

Councilman Grasso said that he has received correspondence with concern over some of the utility poles owned by Verizon. They said that some of the tops of the poles have been cut off by Verizon and maybe rotting and may become dangerous. Councilman Grasso said that he would like to go out to inspect them. The Board had no objection.

Councilman Hodgkins recommended a copier company that has copiers available under state contract. The Town Clerk said that the Town Justices may apply for a grant for a copier.

Supervisor Grattidge said that he wants to thank Stewarts Shops for the money they donated to the Charlton Seniors and the West Charlton Fire Department.

PRIVILEGE OF THE FLOOR

Josie Jackson, Cook Road, asked if the Highway Department could clean-up the roadside at the Route 67 and Cook Road intersection. She said that it is very dangerous to pull out onto Route 67 from Cook Road, and the overgrown vegetation makes it more difficult. Supervisor Grattidge said that Route 67 is a State road, and the State usually mows a couple of times a year, although he has not noticed them mow twice this year. Councilman Hodgkins will ask Mike Emerich to contact the State to request mowing the roadside.

Suzanne Voigt, Dawson Road, asked to clarify information about the upcoming Planning Board meeting and the Food Pantry so that she can publish the information.
