A letter was received from Fred Acunto about traffic on Charlton Road at the corner of Division Street. Mr. Acunto noted this as a dangerous corner and requested a speed reduction. The Board will discuss this at the Agenda meeting.

The Town Board was copied on a letter from Terry Vallely, resident on Vines Road, to AIM Services for the property located at 9 Vines Road. The letter details his unhappiness with the goings on at 9 Vines Road.

Councilman Hodgkins said he will ask the Highway Department to do the digging for the new electrical line in Gideon Hawley Park.

Water – Meter reading cards have gone out and are due back by May 25th to avoid a penalty.

Zoning – In April, \$796 was collected in fees for property improvements with a total value of \$145.400.

Seniors – Councilman Gay said that he is working with the Seniors to come up with a plan for improvements at the Community Center.

Constables – In April, there were 29 patrols, 31 complaints, 13 911 calls and 3 accidents & 1 EID call responded to. 68 tickets were issued of which 15 were issued on Route 67. For the period of January through April 2017, a total of 281 tickets were issued by the Constables.

Dog Control – In April, there were 10 complaint calls received, 2 expired licenses followed up on, 1 dog bite reported, 11 dogs seized and returned to owners.

Parks – An electrical line is going to be installed in Elmer Smith Park. A quote was received for \$1,300.00 for materials and labor. Supervisor Grattidge asked if pickleball lines could be painted on the tennis courts when the tennis lines are painted on.

ECC – Marv Schorr said that the roadside clean-up on April 29th was a success, and he thanked the Highway Department for their assistance picking up the trash bags. He said that the Charlton beautification program of giving out free tree seedlings was very popular again this year.

Historian – Mr. Livingston reported that he attended a very interesting meeting with the County Historian on May 2nd. The work on the Charlton book continues. On May 13th, the annual marking of the Charlton Veteran graves with done. He is doing research on the Van Heusen family. There is a heavy time capsule at the Community Center and he would like to have it moved to and displayed at the Town Hall. He now has access to the County Historian records online. He said that the flags for the Charlton Veteran graves were donated again this year by Gadsden and Culpepper.

COUNCILMAN REPORTS

Councilman Hodgkins said that the next Party in the Park Committee meeting is May 23rd.

Councilman Heritage asked the Historian Marv Livingston if he had information about the formation of the Veterans Memorial Board Committee. Mr. Livingston said that he will be able to provide some information.

Councilman Grasso asked if there was wi-fi available at the Town Hall. Supervisor Grattidge said there is not wi-fi available to the public. The Councilman noted that there is paint peeling on the west side of the Town Hall, so he said that the Board will need to keep an eye on it. He said that he will schedule the workplace violence training for Town employees and Officials.

Councilman Grasso said that the Planning Board did complete the site plan review of the Stewarts' application. They will review a lot line application at their April meeting.

Councilman Grasso said that he has reached out to Dave Brennan who represents Verizon Wireless, and he has not heard back yet. There is no new information about the cell antenna project at this time.

PRIVILEGE OF THE FLOOR

Marilyn Phillips, Sacandaga Road, said that for many reasons she would like to see the sign on the Stewarts property say welcome to West Charlton. There is already welcome to Charlton signs at the boundary lines.

Ed Snyder, Division Street, said he has concerns with a sole appointed Assessor because they would be dependent on the approval of the Town Board. He asked if there is an advantage to a single Assessor, he would like to know what that is. He said with an appointed Assessor, the people lose the right to vote. Supervisor Grattidge said that the Public Hearing will be held on May 22nd. There is an article from NYS Real Property about the benefits of sole appointed Assessor. Supervisor Grattidge said that 94% of Towns in New York State have a sole Assessor, and Charlton is the only Town in Saratoga County with 3 Assessors. Currently there is one vacant Assessor position, and another position that will be vacant at year end. The head Assessor, Kim Caron, has expressed an interest in becoming sole Assessor. The Supervisor said that it has always seemed to be that there was one strong Assessor and the other Assessors tended not to be as strong, so the workload was put on the main Assessor. The sole appointed Assessor will have a term, and at the end of that term, the Board can assess the position and make changes if need be. Because the position will be appointed, the Assessor does not need to live in Charlton. The position has become more technical, so this gives the Town a bigger pool of qualified people to do the job. Councilman Grasso said that he has been on the Town Board for three years, and he has never seen the integrity of the Assessor's office questioned or impacted by the Town Board. He also said that it is the Town Board's decision to make and to do what they feel is best for the Town, If people don't like it, they can vote the Board out. Councilman Grasso said that the reason the Board is choosing single appointed over single elected is because the elected person must live in Charlton and the appointed position does not require that, so there is a larger pool to find someone qualified in.

Josie Jackson, Cook Road, said that she feels the new Stewarts is good for the community, Every morning when she drives to work, she must make a left onto Route 147 from Route 67, and she said that it is very difficult to make a left hand turn. She asked if there was going to be a left turn lane put in when Stewarts goes in. Supervisor Grattidge said that Stewarts must apply to the State for curb cuts. Councilman Grasso said that there is no turn lane in the current plans. Mrs. Jackson also said that it is difficult to pull onto Route 67 from Cook Road because of the speed of traffic on Route 67. Supervisor Grattidge said that the Charlton Police have concentrated their efforts on Route 67 to try to help control speed. Councilman Grasso said that the Town has shared the concerns with the State DOT, and it is up to them to do something. Mrs. Jackson also asked if the reason that the Board wants to go to sole assessor is because there is not enough work and was only one Assessor handling a file anyways. Supervisor Grattidge said that the workload is split between the 3 Assessors (currently 2 Assessors) but each one only works 3 hours a week, so one person could handle the workload by working 3 days. There will be an assistant for data collection and a clerk. Mrs. Jackson was thankful for the brush pick-up and the good job done by the Highway Department.

Larry Leone, Maple Avenue said regarding the Verizon application, a petition was signed in the last 2 weeks by over 100 people asking the Board to deny the application for the tower at 764 Charlton Road, and find another location. The results show that people care about Charlton's future as outlined in the 2007 Comprehensive Plan. They would prefer an antenna on an existing structure.

Eileen Stone, Charlton Road said that she agreed that the corner of Route 67 and Cook Road is a dangerous corner. She also feels that turning left on to 147 from 67 is also a problem. She said regarding the Verizon application, the ECC met and sent a letter to the Town Board on February 7th. She appreciates the time that the ECC put into comparing the water tower location and the 764 Charlton Road location. She has not seen any feedback or response to the ECC letter from the Town Board. She feels that it is very important when the Board is making a big decision, especially one that goes against our own Zoning Ordinance to co-locate. We deserve very specific rationale for the continued pursuit at 764 Charlton Road. The ECC letter included "we are puzzled by the decision by the Town Board to ask for Verizon to purpose moving it to a standalone cell tower. It is specious reasoning by nearby residents to suggest that adding antennas to the top of the water tower could have any significant impact on land values in the immediate area given that the water tower was there when residents of Cherry Lane purchased those residences. It makes little sense from an environmental standpoint to not use the water tower for the cell phone equipment. It is difficult for the Environmental Conservation Committee to understand the rationale of the Town Board in rendering its decision to abandon the use of the water tower and site the cell phone equipment in a standalone open field tower, a decision that runs counter to the Town's Zoning Ordinance recommendations, to the Comprehensive Plan that was approved in 2007, and serves to exacerbate the only significant negative environmental impact in siting the cell phone equipment, the visual impact. Mrs. Stone said that she would appreciate feedback from the Town Board, and asked the Board to put in writing why they are still pursuing the Charlton Road site. She also asked the Board to ask Verizon to do a property assessment on the 764 Charlton Road site, in addition to the photos that we requested.
