The Saratoga County Open Space Grant application period opened on June 1st and runs until September 1st. The County has allocated \$150,000 to the grant program for the purchase of development rights on productive agricultural lands and to acquire open space lands whose preservation is deemed to be of significant public benefit.

Supervisor Grattidge said that Councilman Grasso has conducted the Workplace Violence Prevention training as required by New York State with all but one of the Town employees. He has scheduled a training time for the remaining employee.

COMMUNICATIONS

New York State Department of Taxation and Finance has sent a notice that the Town's Equalization Rate for this year is 70%.

The Board has received a letter from Charlton Oil requesting the Board to remove consideration of the Exceptional Use Permit application that we previously submitted for 151 and 154 Crane Street. He would like the current permit to reflect the current usage. Supervisor Grattidge suggested discussing this at the next Agenda Meeting and asked Attorney Van Vranken to research the EUP history.

DISCUSSION

A request was made by Stewarts' Shop for further discussion regarding the sign. The Board agreed to discuss this at the Agenda Meeting.

Supervisor Grattidge said the he received a letter from Mrs. Jones on Dawson Road about a tree that is down in the stream behind her property. She believes that the property belongs to the Town. The Board will ask Mike Emerich check into this.

DEPARTMENT & COMMITTEE REPORTS

Highway – The Department has been working on drainage issues on Peaceable Street and Maple Avenue, as well as clean up after the Party in the Park event.

Dog Control – In May, there were 13 complaint calls received, 2 dog bite reports filed, 4 dogs seized and returned to owners.

Constables – In May, there were 29 patrols, 25 complaints, 10 911 calls and 2 accidents & 1 EMT call responded to. 70 tickets were issued of which 47 were issued on Route 67.

Historian – Marv Livingston reported that the marking of the Veteran graves in Charlton was held on May 13th. There were 14 students, 6 parents and 2 teachers that assisted. The Historian thanked Larry Leone and Gadsden and Culpepper for donating the flags again this year.

Justice – Councilman Heritage said that this is the 20th year of service by Judge Ketchum. The Board offered congratulations.

Parks – Councilman Heritage said that the Committee will meet June 13th at 7pm.

Water – Hydrant flushing has been done in the northern end of the system. There is a definite correlation in the system flushing and the increased cost of water usage. The Board had budgeted extra money for this year in anticipation.

The Seniors have offered to volunteer their services if the Town pays for the supplies. They will be installing new sinks, vanities, faucets and repainting the bathrooms including the floors.
